Sir,

In producing herewith one accused person named Kanhaiya Prasad (44) S/o Lt. Mangal Prasad of Kamla Neheru Nagar, Adalatganj, Phulwari, PS. Kotwali, Dist. Patna, Bihar under arrest along with following articles under proper seizure.

Total of 12 bottles of Copenhagen Denmark Tuborg Premium Beer, STRONG having Batch No. 71, Dt. Of Manufacture- 27.11.2021, MRP Rs. 130, each bottle containing 650 ml (Price tagged as 130/- and total of 7.8 liters) and One bottle of Tuborg Premium Strong Beer containing 650 ml (Price tagged as 130/-) taken randomly as sample for examination.

I, ASI Biplab Kumar Das of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Kanhaiya Prasad (44) S/o Lt. Mangal Prasad of Kamla Neheru Nagar, Adalatganj, Phulwari, PS. Kotwali, Dist. Patna, Bihar to the effect that today on 14.07.2023, while performing mobile van duty received a source information at around 19:00 hrs. that one person is carrying liquor in in one black color school bag at Siliguri Junction Bus stand under Pradhan Nagar Police Station without any valid license.

Accordingly, I informed the matter to the I/C PS and as per his kind direction I along with C/762 Majibul Rahaman and CV/128 Ajay Kr. Sahani had been to Siliguri Junction Bus stand area under Pradhan Nagar PS to verify the veracity of source information. On reaching there and as identified by the source found that one person was carrying one Black Color School Bag and waiting for Bihar bus in front of Raj Bus Service at Siliguri Bus Stand.

Subsequently, I along with my force was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above. Further being searched the above noted seized articles were found in the in the School Bag of Kanhaiya Prasad. On demand he failed to produce any valid license/papers for selling and carrying of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06 (six) months at Bihar for his illegal gain and every time he carried liquor from Siliguri.

Then I seized and labeled the above mentioned illegal illicit distilled liquor under proper seizure and arrested the above-mentioned person named Kanhaiya Prasad (44) S/o Lt. Mangal Prasad of Kamla Neheru Nagar, Adalatganj, Phulwari, PS. Kotwali, Dist. Patna, Bihar after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 21:25 hrs to 21:55 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Kanhaiya Prasad (44) S/o Lt. Mangal Prasad of Kamla Neheru Nagar, Adalatganj, Phulwari, PS. Kotwali, Dist. Patna, Bihar under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
