Respected Sir,

I would like to draw your kind attention to the following facts for your consideration and taking necessary step:

That I got married with 'Papai Pal', S/o. Sri Bighuram Pal of South Ektiasal Pipe Line, Lalumore, P.O. Sevoke, P.S. Bhaktinagore, Pin Code — 734 001 and the

said marriage was solemnized on 07.12.2020 in 'Sri Sidheshwari Kali Temple' as per Hindu Rites and rituals in presence of the family members of both the family.

After the marriage I started living with my husband in the house of my younger maternal aunt of my husband from 07.12.2020 to 13.12.2020 at Devidanga, Battala. Thereafter on 13.12.2020 at around 19.30 hrs. I went to my matrimonial home accompanied with my husband at South Ektiasal, Laloomore, near Netaji Subhas School.

During my stay at my matrimonial home my husband namely Papai Pal, my father-in-law Sri Bighuram Pal, and my mother-in-law Jyotsna Pal inflicted torture on me almost everyday. And I was tortured both mentally and physically even I was not allowed to report it to my family members due to their threat. Sometimes I was brutally beaten up by my husband but I could not report it before any forum and to any concerned authorities in time since I was threatened by my husband not to open your mouth to anybody.

Finally I was driven out from my matrimonial house on 15.01.2021 at around 8.30 hrs. in a single cloth and my all belonging including my ornaments, furniture and fixtures and my all stridhan articles which was given by my parents on the event of our marriage function forcibly kept all these articles with them.

Since then I have been residing at my parental home at Telipara West, Debgram, P.S. Bhaktinagar, Pin – 734 006, District – Jalpaiguri, West Bengal and I have been facing tremendous financial stringency to maintain my livelihood. Now I am fully dependent on my father's earning and my father in the only bread earner of our family. I have no independent income.

Be it noted here that my elder sister-in-law Tumpa Pal, W/o. Biswajit Pal, of Tarang Singh Road, South Ektiasal, Ward No. 40 under Siliguri Municipal

Corporation, Pin - 734 001, District - Jalpaiguri near yubak Binda Club and my younger sister-in-law namely Rumpa Pal, W/o. Buddhadev Pal of Surya Shikha Sarani, Hyderpara, near Hari Byke Garrage, P.O. Rabindra Sarani, P.S. Bhaktinagar, District - Jalpaiguri, Pin - 734 006 was also involved with the said Bandwagon. Sometimes they also used to come and stay in my matrimonial home and behaved with me not like a human being. Be it further noted here that their threatening is still continuing

Under the above facts and circumstances you are therefore requested to take all possible steps against them and treat this letter of complaint as first information report to save my life.

Hope you will extend your helping hand and oblige.
