With due respect and humble submission I, SI Kamalesh Joarder of NJP PS, SPC do hereby lodge this written complaint against Subashish Naskar @ Suvo Naskar of Fulbari, PS-New Jalpaiguri, Dist.-Jalpaiguri and 50 others to the effect that today on 05.07.2023 I am along with force namely C/1035 S. Rabidas, HG/1600 S. Dey all are of New Jalpaiguri PS, Siliguri Police Commissionerate detailed to perfom mobile van duty vide New Jalpaiguri PS MCC No.-1524/23 date: 05.07.2023. This refer New Jalpaiguri PS GDE No.- 203 date:05.07.2023. At about 0850 hrs While performing Mobile Van Duty, Duty officer of New Jalpaiguri PS, Siliguri Police Commissioenrate informed me that One Subashish Naskar @ Suvo Naskar of Fulbari, PS-New Jalpaiguri, Dist.- Jalpaiguri along with 50 others blocked the Asian High Way-II at Fulbari Border near Immigration Check Post, under New Jalpaiguri PS, Siliguri Police Commissionerate and hindrance the normal traffic and prevent the entry of loaded Vehicles of Bhutan inside Bangladesh over the issue of Non-Payment of Slot Booking Money though Suvida Portel by Bhutan Vehicle.
