Respected Sir,

Most humbly, I Enamul Haque, Independent Candidate of Booth No. 18/37 under Binnaguri Gram Panchayat, Rajganj Block, District- Jalpaiguri, apprising you that yesterday at about 5:30 P.M. when the casting was going on some hooligans mentioned in the bottom of the F.I.R. from the Ruling Party with improvised arms and sharp cutting weapons came to the aforesaid Polling Booth by deploying their supporters along the Polling Booth and used fire arms with the intent to return back my supporters from casting their Votes, they also assaulted my supporters brutally with sharp cutting weapons and my supporters sustained grievous injury and are admitted in Hospital. The hooligans as mentioned in bottom of F.I.R. of the Ruling Party also burnt many four wheelers and two wheelers of my supporters and also set fire in my shop by explosive substances and thereby damaged my entire properties of the shop-room.

It is pertinent to mention that considering my public support, the hooligans of the Ruling Party Candidate and also the hooligans who were the outsiders of my Booth used fire arms and with sharp cutting weapons forcibly entered into the Polling Booth and assaulted the Polling Officer and snatched away the Ballot Boxes.

In the above premises you are requested to investigate the matter and initiate a case against the below mentioned accused persons as law provided.
