Ambari Out Post under NJP, District- Jalpaiguri, apprising you that I am citizen of India living independently under the democratic country and I being an Indian I have right to vote as per Article- 19 of Indian Constitution and I am well known person and one of the supporter of Independent candidate i.e. Enamul Haque and the local peoples respect me and on 08-07-2023 West Bengal Panchayat Election was held in the respective Polling Both vide Polling Booth No. 18/37 under Binnaguri Gram Panchayat.

That yesterday i.e. on 08-07-2023 at around 7:35 P.M. some hooligans mentioned in the bottom of the F.I.R from the Ruling Party with improvised arms and sharp cutting weapons entered into my house and assaulted me and threatened my family members and also snatched gold weigh about 20 Grams worth Rs. 80,000/- and also destroy my four wheeler Hyundai Venue amounting to Rs. 15,00,000/-, LED TV & one small TV worth Rs. 1,20,000/-, one Royal Enfield (Classic- 350) worth Rs. 2,15,000/-, one Honda Scooty worth Rs. 93,000/- and also taken away Rs. 65,000/- in cash which was kept in my four wheeler i.e. Hyundai Venue.

In the above premises you are requested to investigate the matter and initiate a case against the below mentioned accused persons as law provided.
