Dear Sir,

I want to report an FIR after being tortured
by my husband (Gaurav Mohan Vaid). I
married to Mr. Gaurav M. Vaid R/O Flat 305,
Block 6, Eastend Apartment, Indrapuram,
Ghaziabad, Uttar Pradesh - 201014, on 10th Feb, 2022
at my residence (Block A-17, house no. - 10,
Moti Mahal, Uttarayan, Matigara, Siliguri,
West Bengal - 734000). He is a violent man.
Ever since we got married, he and his
parents has been using physical force on me
and mentally torturing me.

Point 1:- My husband lied about his
financial debts that he was having before
marriage. I started receiving messages from
unknown people, saying that my husband

FIR - has took money from them and has returned. It mentally affected me. When I questioned him, he and his parents started fighting with me both verbally and physically. I mentally affected by it. Till date I receive messages from his friends saying that he is not returning their money.

Point 2:- He asked me money after marriage, saying that he has to clear his debts. Knowing that I was not earning, he forced me to ask my father - amount 50,000/-. I did what they asked me to. I asked my father the amount which he, transferred me in the account.

Point 3:- This is our second marriage. Even after our marriage he kept stalking his ex-wife and was still in relation with her. His parents supported him for

saying whatever he was doing. When confronted him, he fought with me verbally and physically. He is an alcoholic. He never took care of my expenses and kept asking me money to buy alcohol. His parents also supported him, which broke me down emotionally and mentally. Even after all this, I still kept going and trying for our marriage.

Point 4:- In the month of June 2022, I got pregnant. When I told him and his parents about it, they got furious and fought with me. They asked me to leave the house permanently and throwed me out. I came back home. And ever since residing at my parents place. I appealed in front of them and his extended family also to make him understand and talk to him, but no one

FIR - 20 Point 5:- But through my pregnancy, he never took care of me and my expenses, my medical bills, and doctor and medicine bills. Yet even after all that he kept emotionally fooling me and asked for money. All through my pregnancy, I was mentally and emotionally harassed by them. I was in so much stress, but still my husband was busy partying around with his friends and female friends. He even called a female friend at home, in the presence of his parents. Drank alcohol and spend time in our bedroom.

Point 6:- After all this, he came here and apologised in the month of January 2023, I accepted him for our child. But when he was here at my parents place

fought with my father for money. After the apology, he still didn't change. He still didn't take care of his responsibilities. He wanted my parents to take care of him and my expenses. He always said that it was my mother's duty to take care of me and my expenses. Now, after 4 months of my delivery he and his mother came once for formality. His mother clearly said, that they will not take care of me and my daughter.

I have been keeping the matter quiet to keep the marriage alive for my daughter but now he is not taking care of our daughter, financially (supported by his parents). They have clearly said that they will not take care of us anymore. I also fear for our safety as our life

he could be in danger.

I am, therefore, bringing this issue to your notice and request you to register an immediate F.I.R against my husband and his parents. I also demand expenses for my daughter.
