S. SMT. GITA GHOSH, wife of Sri. Bijay Ghosh, resident of Vill. Tikaitkata, behind Sumiti Bhawan, P.O. Sushrutnagar, P.S. Matigara, Dist. Darjeeling, would like to inform you that two years ago one PRADIP SARKAR, son of Deyal Sarkar, r/o. Charubari, Bhatigara, P.O. & P.S. Maynaguri, Dist. Jalpaiguri, interacted with me via one of my close friend Sumita Thapa, w/o. Utkarsh, r/o. Siliguri and said PRADIP SARKAR obtained my mobile number through my friend without my consent. Thereafter he on several occasions through several mobile numbers contacted me and requested

me to consider him as her younger brother as he wanted to build a family relationship with me and my family and upon his request I reluctantly agreed to his proposal as I felt that he is a nice person. After two months we started to make casual family visits in each others house. One and half years ago, I and my husband visited his house for two days. On the first day of our visit, at evening, when I went to his bathroom for bathing he recorded my nude bathing video through a gap in his mobile phone which I couldn't understand on that moment. Few days later, he visited my house and in the absence of my husband and children he showed me my nude video and threatened me that he shall circulate the video and viral it on different social media platforms if I do not allow him to have sex with me. He eventually raped me in their absence. I did not disclose this incident as because I was nervous that it might come out as I am unchaste and might derogate the sanctity, dignity and respect of my family. Thereafter on innumerable occasions he raped me in my house in the absence of my children and husband. He had even took Rs. 1,30,000+ as loan from me. On 11.07.2023 he again raped me in my house in the absence of my family members and even asked money from me. I became helpless and couldn't resist myself from informing all this to my husband. My husband became furious and scolded him through mobile phone. On 12.07.2023 he visited my shop at Tikaitkata, at about 5:30 P.M. he then suddenly started to pull me out from my shop saying he wanted to take me a lodge for having sex for the last time. I suddenly rang my husband through my mobile phone and my husband immediately arrived at my shop and rescued me from his hands. He threatened me that he shall rape and kill me if we disclose or inform all these to police or anyone else.

I therefore, request you to kindly take necessary legal steps against the aforesaid PRADIP SARKAR and save me from his hands.
