Tapes Jainval was working in Silippet Municipal Corporation and told resoluble registered land out stilmately it is me who is going to gain all the benefits, thus my father agreed to all of their demand thirting that I will stay happily after marriage. Just one week before the state of marriage Tapes Initiated demanded LED TV and Titas Wrist Watch to be given to him during the recoption party to which my father agreed since the marriage card was already distributed among the religious. My deal also transferred Es.3 Iakh in Tapes jaiswal Bank account before the marriage when they

After the marriage as per their domand cash and items stated above was delivered at my In law's house but suffortunately. King size bed was not fitted in my single room after which Tapus Jaiswal demanded to ask my parents to change the woodes king-size bed to a bit smaller one which cost Rs.58000.

When I denoted, he started abusing me using filthy language after which I started crying but all in vain. They stid not allow me to use mobile phone and threatened me that I will not be allowed to speak to my purents and have to sleep on the floor till my parents give them a smaller king size bed. They forced me to sleep on the floor and both Tapas Jaiswal and his mon-dad used dirty language regularly after which I had to ask my purents to suplace the bed which took more than a month and till it was delivered to my house I sleep on the floor only.

It was a daily affair for them to use foul language and curse my parents for not giving them enough money, they only wanted money from my parents and brother. Tapas Jaiswal use to locked me inside a single small room while going for duty in the Siliguri Manicipal Corporation and I was not allowed to stop-outside the room even in his presence. He used to block my parents and brother contact number so that they couldn't contact me mentally torturing both of us.
