Sub: FIR against SUBRATA SAHA (present USER), S/O- Lt Subhash Ch Saha, Add-V/8, Baghajatin Colony, Pin-734003 for bypassing the energy meter (GE0152297) of WBSEDCL at his premises.

Sir,

It is to inform you that I, Debraj Das, S/O- Kartik Ch Das, DE & SM, Pradhannagar CCC; being empowered by the Electricity Act 2003, do hereby lodge a complaint against SUBRATA SAHA (present USER), S/O- Lt Subhash Ch Saha, Add-V/8, Baghajatin Colony for bypassing the energy meter (GE0152297) of WBSEDCL at his premises.

Today i.e on 21.07.2023 (15:00 hrs), I came to Baghajatin Colony; in my official hired vehicle for a routine inspection. I was accompanied by (i) Pranab Sikder, S.O(S&LP), Darjeeling Region, (ii) Gunjan Tamang, SrTSH, Pradhannagar CCC & other technical staffs of Pradhannagar CCC.

On inspection of the premises (after observing all formalities), I found that the meter GE0152297 (Meter is in the name of Lt Subhash Ch Saha but the present user is Subrata Saha) was bypassed at the incoming of the meter and power was enjoyed illegally.

I disconnected the connection & seized the meter along with the bypassing arrangement (on sample basis), after preparing the seizure list duly signed by the witnesses and the accused. Local people were present but none appeared.

We left the site at 15:10 hrs.

Seized Articles:

- 1 phase energy meter GE0152297, 240V, 5-30A, Make- Genus along with tapping/bypassing point.

SUBRATA SAHA was present at the site and received the copy of Notice, Inspection Note & Seizure list.

As such, SUBRATA SAHA, has committed unauthorized use of electricity by bypassing/tapping the existing meter for his illegal gain.

Please treat this complaint as FIR U/S 135 1(a) of Electricity Act 2003 against present user SUBRATA SAHA.
