I, Babu Saha, son of Sri Abhiram Saha, resident of Rajarammohan Ray Road, Hakimpara, Ward No. 15 of Siliguri Municipal, Post Office & Police Station Siliguri, District Darjeeling, would like to state that I am constructing my 3 storied building at Himanchal Bihar in Plot No. C-93, 2 No. road and for that purpose I had hired a Contractor namely Shefal Das, father's name not known (mobile number 62961-90275), resident of Kawakhali, Post Office Sushrutnagar, Police Station Siliguri, District Darjeeling, Pin 734012 to complete the construction work. It is pertinent to mention here that before giving the work to complete my building to said Contractor roof casting of the said building was already been completed and for rest work I had hired him.

That on 19.07.2023 said Shefal Das had visited my shop situated at Bidhan Road where my wife namely Ela Saha was present and looking after the shop work as I was out of Siliguri since few days. That said Shefal Das ask my wife to pay a sum of Rs.20,000/- (Rupees Twenty Thousand) only for the work which he is doing. My wife asked him to contact with me as I am aware and engage said Shefal Das and I am looking after the said things and she cannot do anything in that. That as I was out of town said Shefal Das had contacted me over phone and I told him that I was out of town and after two days I am coming and thereafter pay the amount after seeing the progress of my site/constructing. That said Shefal Das had threatened me over phone that I

have to give him the noney right that point of time or otherwise he will demolish the structure of my said building and cut the phone calls and thereafter also threatened my wife with dire consequences. That when I came back to Siliguri I visited my construction site and astonished to see that said Shefal Das as threatened by him had demolished the entire structure of 3rd floor of my said building and also tried to demolish the second floor. That I notice that the goods such as cement of 15-20 begs, 70-80 iron rod, plumbing items, etc. was not there and all have been stolen away by said Shefal Das. As such I tried to communicate with said Shefal Das and he accepted that he had demolished the said structure on the night of 19.07.2023 with the help of other unknown persons and also theft away my aforesaid goods. That due to such illegal acts and activities of said Shefal Das I had incurred huge loss and also suffering with mental pain and agony.

Under the above circumstance I hereby lodging this complainant against Shefal Das for his illegal acts and activities and would request you to investigate the matter the wrongdoer can be punished as per the procedure established by law
