With due respect, I Sri Amitava Saha Roy, Son of late Hari Narayan Saha Roy, Resident of Netaji Subhas Road, Subhaspally, Ward No – 20, of S.M.C., Siliguri, P.O & P.S – Siliguri, District – Darjeeling, would like to lodge this written complaint to the effect that I am a business person and I am also the owner of several busses and I have been using those busses for the transportation of the students of several English Medium Schools. As usual in the morning time, the busses went out from the parking place which is situated at Aurobinda Pally Main Road, and started to pick up the students from the starting point and left the student to the destination and after completion of the School hours, the busses returned back from the school with the students and left the students accordingly to their destination point. After completion every day routine duty, the drivers of every vehicle parked their respective vehicle in the parking lot as aforesaid. Since last two months about 20 numbers of batteries of my different vehicle has stolen away and inspite of posting of security guard, we could not locate and trace out the person who has stolen away the batteries of different vehicles and also stolen away the fuel of the vehicles.

Today at the evening time at about 7:00 P.M. when all the vehicles were parked in the parking lot, my engaged staffs and drivers found and saw one person who is trying to collect the fuel from the vehicles after cutting the pipe of the fuel tank and seeing the said situation, they apprehend the said person and caught him in red handed and at that time the adjacent peoples as well as the peoples who were passing the road reached there and manhandled the said person. On being query, the apprehended person disclosed his identity as Biplab Singh, Son of Bakul Singh of Post Office Gali, Shahid Colony, Bhaktinagar, Siliguri (M. Corp)., Jalpaiguri, Bhaktinagar, West Bengal 734007 and the said person also confessed his guilt and

stated that he along with his associates have stolen the battery of the vehicles as well as stolen fuel from the tank of the vehicles. Immediately after receiving the information, I went to my parking place and recover the said person from the gathering of the peoples and also took him at Siliguri District Hospital, where the attending Doctor treated him and presently the said person is in the Siliguri District Hospital.

I therefore, request you to investigate into the matter and please take appropriate legal steps against the said Biplab Singh and his associates as per the provision of Law and obliged thereby.
