I SI-Pradeep Diylai of New Jalpaiguri PS, Siliguri Police Commissioenrate beg to report before you that on 29.07.2023 at about 0435 hrs received an specific source information that 05 (Five) Bangladeshi women were coming from Bangladesh and will received by three local persons for giving them accommodation at their resident by illegally means without valid passport/visa at Noukaghat More. Under New Jalpaiguri PS, Dist- Jalpaiguri. Accordingly I informed the matter to SI-Partha Sarathi Das, Officer-In-Charge, New Jalpaiguri PS, Siliguri Police Commissionerate as well as Assistant Commissioner of Police, East-II, Siliguri Police Commissionerate and as per their direction of my superior, myself along with ASI-Khagen Barman, VP/13 Jamirul Islam, C/453 Uttam Dey, C/1044- Hari Kherwar, LC/1235-Anita Roy, LC/746 Atoshi Roy all of New Jalpaiguir PS, Siliguri Police Commissionerate left PS to verify the veracity of the information. This refer New Jalpaiguri PS GDE No.- 1179 date: 24.07.2023 and MCC No.- 1637/23 date: 24.07.2023. In the mean time, I also informed two independent witnesses namely (i) Sukamal Sen Gupta s/o Lt. Subir Sen Gupta of Shaktigarh, Road No.- 03, PS-New Jalpaiguri, Dist- Jalpaiguri (ii) Buddhadev Saha s/o Arun Saha of Suryasen Colony, Ward No.- 34, PS- New Jalpaiguri, Dist- Jalpaiguri during search and seizure if any. At 0525 hrs Myself along with force arrived at Noukaghat, under New Japaiguri PS, as per indication of source, we found that 08 (eight) persons including 05 (Five) women were standing at Noukaghat More, and seems to proceeded somewhere. Accordingly as per indication of source, we apprehended Eight accused persons including 05 (Five) women which seems alight from some vehicle and planning to proceeded to somewhere with three male persons. On being asked they gave different statement in different time. After prolonged interrogation they disclosed their name and address as noted
