Sir,

With due respect, I am producing herewith one arrested accused person namely Badal Sah(35yrs) S/O Lt Rajendra sah of Southcolony Majdur Basti, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

- I. 10 (Ten) bottles of Himalayan Gold 60 UP Country Spirit each bottle containing 600 ML.
- II. 12 (Twelve) bottles of KACHI 70UP country spirit each bottle containing 300 ML.
- III. 04(Four) bottles of premium King each bottle containing 650 ML.

I, ASI Dhruba Misra presently attached with NJP PS under your kind control beg to state that today i.e. on 25.07.2023 at 17:35 hrs I received a secret source information that one person namely Badal Sah(35yrs) S/O Lt Rajendra sah of Southcolony Majdur Basti, PS- NJP, Dist.- Jalpaiguri is selling I/D liquor illegally at his resident located at South colony, PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 1263 dated 25.07.2023 and informed the fact to you. As per your kind direction and instruction myself along with C/ 1-114- Hari Kherwar & C/ 453- Uttam Dey all of NJP PS, SPX left for southcolony Bazar, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 18:05 hrs we arrived at South colony Bazar, PS- NJP, Dist.- Jalpaiguri and being identified by the source I found the said accused person selling illegal Distilled liquor to his regular customer at his Shop situated at Southcolony Bazar and as per the indication of source managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling I/D liquor at his Shop at Southcolony, under NJP PS since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from the his possession. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 18:35 hrs to 19:15 hrs

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Badal Sah(35yrs) S/O Lt Rajendra sah of Southcolony Majdur Basti, PS- NJP, Dist.- Jalpaiguri and obliged.
