I, Arpita Sarkar, wife of Sri Amit Sarkar and Daughter of Late Sadhan Das presently residing at Lake Town, Sreema Sarani, beside Sunrise Club, Ward No. 33 of S.M.C, P.O. Bhaktinagar, P.S. New Jalpaiguri, District Jalpaiguri, Pin 734007, West Bengal, would like to state that I am the legally wedded wife of Sri Amit Sarkar and our marriage was solemnized on 01.05.2006 as per Hindu Rites & Customs at Surya Sen Colony, Block E, Post Office Siliguri Town, Police Station Bhaktinagar now New Jalpaiguri, District Jalpaiguri. That thereafter the said marriage has been registered before the Hindu Marriage Registrar Jalpaiguri on 23.08.2006 under Hindu Marriage Act, 1955. That prior to marriage my husband informed me that he was working in a private firm and earning a sum of Rs.20,000/- (Rupees Twenty Thousand) only per months but soon after my marriage I came to know that he was doing nothing and was jobless as such my in-laws was to bear all the household expenses as such they also used to taunt me for the same. That out of the wedlock I gave birth to a male child namely Deepayan sarkar on 17.02.2010. That in the year of 2021 my father died as such I along-with my husband moved out from the flat and shifted in my parental house.

It is pertinent to mention here that after the death of my father, I inherited some movable and immovable properties from my father. That after the death of my father, the behaviour of my husband towards me became quite well but as the day passed he started to create mental pressure upon me to sale out the entire property of my father and fix the amount so that we do not have to work and use the money on monthly basis to fulfil our basic needs but when I refused to do so I was subjected to mental and physical torture in the hands of my husband. That my husband is threatening me with dire consequences if I will not sale the property left by my father and give money to him he will spread out the rumor among my relatives and friends that I am a lady of compromising character and having an adulterous relationship with number of men and malign my character in the society. That as my husband has no income of his own

he threatened me to provide him a sum of 18,30,000/- (Rupses Thirty Thousand) only every month in the month of pine 2023 to meet his materialistic things and whenever (failed to do so I was assaulted brutally by him. That being subjected to physical and mental cruelty in the bands of my husband, my life is in a interable state in spite of this fact that over the period of time I have look after him and supported him in all ups saddown. That I am/was brutally assaulted by my husband on number of occasions, and in the month of January 2023 he tried to kill me and my inhor child by keep opening this gas oven when I and my minor child was sleeping but somehow I managed to keep safe myself and my minor child every time.

That since few days my husband spreading rumour about my character in my relative and near once as such they used to see me with a doubtful eyes but they do not know that my husband is doing such illegal acts and activities just to suffice his materialistic needs and want from me to sale the entire property of my father which I had received after his death. It is needless to mention here that my husband is planning to kill me and he also threatened me with dire consequences if I will not sale and give sale proceeds to him or transfer the property of my father in his name. I have a sense of feat that my husband will kill me soon.

Under such constrained circumstances I hereby lodge this complaint against my husband Amit Sarkar @ Amit Kumar Sarkar, Son of Sri Pradip Kumar Sarkar, Resident of Sunilanjali Apartment, Nabagram, Sukanta Sarani By Lane, Ward NO. 33 of S.M.C, P.O. Bhaktinagar, P.S. New Jalpaiguri, District Jalpaiguri, PIN 734007 and would request you to do the needful as soon as possible so that the wrongdoor can be punished as per the procedure established by law.
