In producing herewith one accused person named Pankaj Kumar Kunvar(44y/M), S/O. Akhaleshwar Kunvar of Vill. Chorniya, PO. Chiraila, Ps. Gayghat, Dist. Muzaffarpur, State. Bihar under arrest along with following articles under proper seizure.

Twelve (12) bottles of BUDWISER PREMIUM KING OF BEER, each bottle containing 650 ml, each bottle MRP-154 rupees (Total 7.8 litr). marked as exhibit A (Out of which one has been taken as sample for examination marked as exhibit A1)

I, ASI Manoj Kr. Roy of Pradhan Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Pankaj Kumar Kunvar(44y/M), S/O. Akhaleshwar Kunvar of Vill. Chorniya, PO. Chiraila, Ps. Gayghat, Dist. Muzaffarpur, State. Bihar to the effect that today on 30.07.2023 at 20..25 hrs received a source information that one person has been carrying huge illegal liquor at Siliguri Junction under Pradhan Nagar Police Station without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction I along with C/762. Majibul Rahman, CV/645. Pankaj Gupta and CV/223 Swapan Chettri ( All of Pradhannagar Ps) had Siliguri Junction under Pradhan Nagar PS to verify the veracity of source information vide Pradhannagar ps GDE no. 1857, Dt. 30.07.23. On reaching there and as identified by the source found that above noted person has been carrying illegal liquor at Siliguri Junction. Subsequently, I along with my force able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above . Further being searched the above noted seized articles were found in a cartoon. On demand he failed to produce any valid license/papers for carrying and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 01 (ONE) year for his illegal gain. Then I seized and labelled the above mentioned illegal illicit distilled liquor under proper seizure list in presence of independent witnesses and arrested the above mentioned person named Pankaj Kumar Kunvar(44y/M), S/O. Akhaleshwar Kunvar of Vill. Chorniya, PO. Chiraila, Ps. Gayghat, Dist. Muzaffarpur, State. Bihar after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 20.40 hrs to 21.05 hrs at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Pankaj Kumar Kunvar(44y/M), S/O. Akhaleshwar Kunvar of Vill. Chorniya, PO. Chiraila, Ps. Gayghat, Dist. Muzaffarpur, State. Bihar under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
