With due respect, I, SI Binup Mahato of Bagdogra PS, Siliguri Police Commissionerate, hereby lodge this written complaint against owner and driver of Tractor No. 1970 44 and some unknown procession. Sir, do hereby lodge this written complaint against owner and driver of Tractor No. WB-61-A-8144 and some unknown persons to the effect that on 21.07.23 at 13-55 hrs he received a source of information that some loaded Tractor were seen carrying with river bed materials illegally at Balasan river side. Accordingly I informed the matter to you and duty officer and as per your kind instruction myself alongwith force VP-02 Pradip Roy, CV-375 Jogesh Barman, CV-389 Janak Singha and also evening mobile van officer ASI Balaram Roy and force C/540 Mintu Barua, CV-135 Dhriti Sarkar proceeded to Balasan river side to verify the veracity of the information which noted in Bagdogra PS GDE No. 934 dtd. 21.07.23. At about 14-35 we reached Dhimal near Balasan river and found that the above noted Tractor loaded with riverbed materials was coming from Balasan river side towards Dhimal . I alongwith force stopped the said Tractor having No. WB-61-A-8144 loaded with riverbed materials at Dhimal near Balasan river, but the driver got down from the vehicle and flee away from there and found that the said Tractor was loaded with river materials. It is reason to believe that the driver of the tractor was carrying the riverbed materials by means of theft without any valid documents/papers illegally for their wrongful gain which causing huge revenue loss to the Government of West Bengal. Then when I was ready to seize the said tractor at that time some unknown persons rushed to the spot and surrounded the tractor to deter police personnel to discharge their Govt. duties. As the situation deteriorated, we tried to explain to them but they ignored us and forced the tractor to start without the key and ran away from there with the said tractor and left the key as the key was in our custody. Then we seized the key as per proper seizure list. On enquiry it could be learnt that the driver and the owner of the tractor were among the crowd of unknown people.

I therefore, pray before you that a specific case may kindly be started against owner and driver of Tractor No. WB-61-A-8144 and some unknown persons and arrange for investigation.
