With due respect I ASI Sushanta Sarkar of Bagdogra P.S. under Siliguri Police Commissionerate do here by lodged a written complaint against unknown persons to the effect that on the night of 22/07/2023 while myself along with C/317 Kartick Roy and C/900 Hrishikesh Barman were performing night patrolling van duty vide Bagdogra P.S.GDE No- 959 dated 21/07/2023 at Bagdogra P.S. area, at 03:45 hrs received an information that some people are going towards Bagdogra side on foot with buffaloes in order to dispose the same clandestinely for their wrongful gain. If the information would not be perused immediately those buffaloes would have been concealed by them. Accordingly the fact is informed to O/C Bagdogra PS and as per his direction I along with force left for Kestopur under Bagdogra P.S. to verify the veracity of the information . At 04:05 hrs. we reached at Kestopur and started waiting near Kestopur More and looking for buffaloes . Just after few minutes we saw that two or three people are coming towards Bagdogra Side with buffaloes on foot and from a considerable distance immediately we prepared ourselves and detained 6 numbers buffaloes and three persons fled away in multi direction from the spot . From this it can be understood and reason to believe that the accused persons had procured the buffaloes by illegal means or by stolen means for dishonestly disposing the same for their wrongful gain . Thereafter I seized the 06 numbers of buffaloes in different size as per proper seizure list duly signed by the witnesses. The seizure was made in between 04:20 hrs to 04:45 Hrs. On primary enquiry it could be learnt that the accused persons have an organized illegal buffaloes supply racket in surrounding Siliguri area and also it could learnt that one Raju Roy is directly involved in this case . Apart from this he is the king pin of cattle and buffaloes supply racket and today he along with his associates was proceeding towards Fullbari side with buffaloes on foot in order clandestinely dispose the same for his wrongful gain which they brought by stolen means.

Therefore I pray before your honour that a specific case may kindly be started against Raju Roy and others as per proper section of law and arrange for its investigation.
