I, SI Binup Mahato of Bagdogra PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Surendar Tirkey (31) s/o Pusha Tirkey of Bhuttabari PS Bagdogra Dist. Darjeeling under arrest along with following seized articles;

- Nine (09) Nos sealed Bottles of Himalayan Gold Country spirit 60 up, each bottle 600 ml, Marked as Exhibit-A from which 01 bottles taken as sample for examination Marked as Exhibit-A1.
- 2. Nine (09) Nos of sealed Bottles of Kingfisher strong premium beer, each bottle 650ml, Marked as Exhibit-B from which 01 bottles taken as sample for examination Marked as Exhibit-B1

I am submitting a written complaint against the above noted accused person to the effect that today on 22.07.23 at 19-15 hrs I received a secret source of information that one person was selling Liquor illegally from his shop named Joy Kali Dhaba situated at Bhuttabari customers without any valid license. Accordingly I informed the duty officer of Bagdogra PS and O.C. under PS Bagdogra to its Bagdogra PS and as per his direction myself alongwith C/851 Chandan Debnath, VP- 02 Pradip Roy CV-389 Janak Singha left for Bhuttabari under PS Bagdogra to verify the veracity of information which noted in Bagdogra PS GDE No. 1005 dt. 22.07.23. On arrival at the spot at 19-45 hrs as shown by the source it was found that one person mentioned above was selling liquor illegally from his shop named Joy kali Dhaba to his designated customers to earn huge money for his livelihood. On seen the police party the customers as well as seller tried to flee away, but the seller was apprehended by police, on being asked he disclosed his name and address mentioned above. Thereafter in the presence of witnesses (1) Utpal Goswami (45) s/o Lt. Ajoy Goswami of Gossainpur Boby Colony PS Bagdogra Dist. Darjeeling and (2) Prem Gour (36) s/o Lt. Shib Nath Gour of Hospital More PS Bagdogra Dist. Darjeeling I recovered (1) Nine (09) Nos sealed Bottles of Himalayan Gold Country spirit 60 up, each bottle 600 ml and (2) Nine (09) Nos of sealed Bottles of Kingfisher strong premium beer, each bottle 650 ml from his possession from his shop and seized the same as per proper seizure List and lebelled duly signed by him and also witnesses. On being asked the said person failed to produce any document or license for selling the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 41 Cr.P.C. as It's a violation under Bengal Excise Act. The seizure & arrest was made in between 19-55 hrs and 20-45 hrs (seizure Total approx 11.2 Ltrs).

Therefore, I request you to start a specific case under proper section of law against the person namely Surendar Tirkey (31) s/o Pusha Tirkey of Bhuttabari PS Bagdogra Dist. Darjeeling and arrange for its investigation.
