This is to inform you that myself Mr. Gyanendra Rai S/o Mr. Bhakta Bahadur Rai presently staying in House No.154, Lane No 2, Defense Colony, Bagdogra, District Darjeeling, West Bengal.

Today while going through my bank statement of SBI Account No. 31559585903 of Bengdubi Branch I have noticed that behind my back my wife Mrs. Vandana Kumari Subba D/o Late Mr. Basant Kumar Subba presently staying in House No. 154, Lane No. 2, Defense Colony, Bagdogra, District Darjeeling, West Bengal and the resident of Flat No. 301, JLMB Encore, 1st Cross, TK Reddy Layout Road, TK Reddy Layout, Banaswadi, Bangalore- 560043, Karnataka and her mother Mrs. Durga Subba W/o Late Mr. Basant Kumar Subba resident of 4-126/141, 142, K Block, Defense Employees Colony, Kismatpur, Rajendranagar, Hyderabad-500086, Telangana took away money from my SBI Account using my SBI ATM Debit card from SBI Indian Air force Camp Branch in Bagdogra without my permission. They took out Rs 48900/-. The available bank balance was Rs 245/- after the money was taken out.

It is pertinent to note that on 29th April 2023 while I was arranging my belongings before returning to Bangalore from Bagdogra with my wife I found that my Diary, Passport with US Visa, SBI Account Passbooks, SBI Debit Card and Car Documents were missing. I asked my wife whether she took those or not but she flatly denied. It is further to mention that the said Diary has the Password of my new SBI ATM Debit Card. To note that the Diary has Banks Account Usernames, Passwords and other important information on it. So, I could now realize that she along with her mother withdrawn the money from my SBI Account using ATM Debit Card by using the Password collected from the Diary which was done with pre motivated mind.

She and her mother have stolen away my money for doing wrong things; therefore; I request your authority to investigate the matter and start a strong case against them and recover my belongings.
