In every monthly meeting, she used to take cash from all of us, i.e total 10 persons including her. As she was depositing principal with interest regularly in this above said group cc account being no: 4001201330002524 and sb account being no: 4001201030057456 of Uttarbanga Kshetriya Gramin Bank, Branch-Bagdogra, But from the March 2023, she has not depositing any amount in this group neither principal nor any interest.
