Sir, on last day i.e. on 01..08.2023 when I was in bathroom for taking shower, I kept my **one pair of gold earrings and other jeweleries including 2 nos. of golden chain and anklet(payel)** on my bed and thereafter when I came out from the bathroom I found that

I, therefore, request you to register this complaint as FIR and please take necessary legal steps against the above mentioned persons and other miscreants as per the provisions of law and obliged thereby.
