Respected Sir,

With due respect I would like to inform before you that on 02/08/2023 at about 9 p.m. some miscreants namely-  
1) Ananda Roy s/o Bashu Roy, I.O.C. Road, NJP, Roypara,  
2) Utsab Roy, 3) Tupai Roy, 4) Ganesh Roy, Roypara & more  
15 unknown persons who are going on the Road in front of our residential house, where we all the family members who were standing there suddenly the said miscreants alongwith 15 unknown members pick-up my Mobile set which is kept in my hand then I have told them to return my Mobile set then they bring that Mobile set but not return the Mobile set, the time is 11.45 p.m. thereafter my husband who had gone to NJP Police Station to lodge complaint, then after calling by the P.S. through their cell phone then the said miscreants has return the said Mobile set and told that why my husband had gone to the police station for lodging the F.I.R.

That it is pertinent to mentioned here that while the said miscreants return the Mobile set then the said miscreants were came with gun/pistol to threaten that they kill us if the matter informed to the Police station, thereafter they pushed me ultimately I try to escape myself from the incident but fell down on my residential gate/entrance then I suffered in physically injured on my head due to hit of Iron pipe using on my head. Thereafter I had used to attained medical examination/treatment on my body till this time I have suffered pain on my head.

Thereafter I have searched my golden chain value of Rs 68,000/- only which is not traced out after the above incidents. The copy of bill is annexed herewith for your perusal. And another medical treatment papers is annexed also.

so I am informing before you to take legal appropriate action against the above named miscreants and punish them according to concerned provisions of law.

I will be highly obliged if you take necessary action immediately.
