against my husband after being continuously
tortured that is physically and mentally. Name
Hasibor Singh, constable no 3010 present
posted in Siliguri police Commissionerate. Since
the beginning of my marriage which caused
in the month of May 2012. I was subjected to
immense verbal abuse, physical torture of
every kind including mental torture, rude
behaviour. He even used to doubt my
character when I used to go to my
duty as a staff nurse working at Bagdogra
PHC, in Department of Health and Family
welfare. Many a times he used to show up
at my workplace and abuse me verbally
using strong languages in front of the patients.

and other hospital staffs he used to abuse my elderly and sick parents instead of my kids day after day. Despite of all these atrocities I tried my level best to continue my marriage for sake of my both children. unfortunately his torture has increased to such extent at present that I am on the verge of mental breakdown and its also aggravating. He never has taken any responsibility of my two children and not given money. In the month of May, June 2023 we are shifted to new flat at Matigara, hence he used to doubt my character even more. There also he used to beat me and physical torture, rude behaviors. He also beating me in front of my kids. whenever I come from my duty to home that time he doesn't talk to me well.

Therefore in order to survive by myself and my two small children and my sick elderly parents. I have decided to go for dissolution of marriage for mental and physical safety and security. Hence I request you to kindly consider my unfortunate situation and give me proper security if needed against this man if he tries to torture me again.
