Accordingly I, diarized the matter vide GDE Entry No. 685, dated, 10.08.2023 and informed the matter to Officer In charge of Matigara Police Station and as per his direction I along with officers and force namely SI Goutam Mallick, SI Agen Lepcha, SI Krishna Chandra Mondal, ASI Dhirendranath Mondal, ASI Pema Dorjee Sherpa, C/1400 Parimal Chandra Mondal. C/1433 Milton Rahaman , LC/1251 Yankila Bhutia, LC/1359 Bhawani Barman, LC/1324 Lalita Singha, LCV/ 82 Papia Choudhary left to work out the information vide Matigara PS GDE Entry no. 686, Dated: 10.08.2023.

At around 14.35 Hrs I along with officers and force reached the 3rd Floor, at Webel IT Park, Phase II and being shown by the source, we held raid at Office of M& M Infosys where some of the staff were working there with computer sets. We introduce them our identity as Police team and on being asked they sated that they were hired three days ago and since then were being trained to make calls to

international customers through internet voice protocol by one operator namely Danny. I asked them about the owner of the Office butwere not able to give any details since they were recently hired at the said office. There was strong reason to believe that the owner of the said company was running the said office illegally for his wrongful gain. Hence I seized the above noted articles with proper seizure list.

I held further raid at the Callytic Solutions and Teleforce Company respectively and found the above noted persons along with some other office staffs were making calls and messages through their computer sets.

I then introduced our team as Police Team and asked them about the owner of the Offices respectively for producing the valid license and other relevant documents for running the said offices. Accordingly the persons namely (1) Anshuman Singh (24) s/o Kundan Singh of 1 No. Baishnav Seth, 1st Lane, PO Beadon Street, PS Jorabagan, Kolkata 06 and (2) Vishal Singh (24) s/o Ajay Singh of 23/1 Darp Narayan Tagore Sreet, Malapara, PO Beadon Street, PS Jorabagan, Kolkata 07. from the office of Callytic Solutions and (3) Debasish Roy (38) s/o Sunil Roy of Netaji Para, Panchanan Road, Eastern Bypass Road, PS Bhaktinagar, Dist Jalpaiguri from the office of Teleforce Company came forward before the Police Team and introduced themselves as the care taker of Office named Callytic Solutions, Teleforce Company respectively.

On being asked they stated that they had been working as the care taker of Office named Callytic Solutions, Teleforce Company for their owner namely Arijit Debnath and Nirmal Sharma respectively. They also stated that they used to provide fake service of Internet upgrade/Speed Test service to the international customers by making international calls through internet voice protocol to cheat the hard earned money of the customers.

On further enquiry to the other staffs of the said offices they stated that they were hired by the owner of the company and being trained since last two or three days for making international calls through internet voice protocol. They were supplied scripts and guided by the above noted accused persons for making international calls.

On demand of Licence and other valid documents to run the Call Centre the above noted accused persons could not produce any DOT Licence or any other documents authorising them to run the said offices wherein they had international clients.
