Enterprises (c/o - Rana Bhattacharya), we check the departmental meter (No.: P1512925 and ID No: 400703557) found that commercial connection was issued to him. Subsequently, due to non-payment of DCRC charge after disconnection on 20.11.2016 and as per WBERC from the date of disconnection 6 months was elapsed and therefore, the connection was declared as deemed disconnected on 07.06.2017.

On physical inspection, it has been detected that said M/S R.S. Enterprises (c/o -Rana Bhattacharya) reconnected the line directly with the WBSEDCL service connection and enjoying the electricity energy since 12.04.2019 unauthorisedly
