I, Asmin Khatoon, W/o Afijul Islam, Daughter of Md. Kayum, Resident of Netaji Nagar, Near- Madrasa, Ward No.42 of S.M.C., P.O-Sevoke Road, P.S- Bhaktinagar, Dist-Jalpaiguri, would like to draw your kind attention in the following matters:

- 1) That a) Afijul Islam ,S/o Soleman Houque (My husband)- 7619552348
 - b) Soleman Houque, S/o Lt. Nabrudin (Father-in-law)-9641645597
 - c) Amina Bibi, W/o Soleman Houque (Mother-in-law)
 - d) Saira Banu, D/o Soleman Houque, W/o Majnu Sekh (Sister-in-law)
 - e) Sajida Khatoon, D/o Soleman Houque, W/o Sohel Rahman (Sister-in-law)
 - f) Sahennaz Bibi, D/o Soleman Houque W/o Rijaul Houque.-7679713686

all are residing at Prakash Nagar, Pramod Nagar, Near- Tower Building, Ward No.42 of S.M.C., P.O- Sevoke Road, P.S- Bhaktinagar, Dist-Jalpaiguri .

- 2) That above mention said Afijul Islam is my legally married husband, our marriage was solemnized on 26.01.2020. At the time of my marriage my parents gave them cash money Rs. 2,00,000/- (Rupees Two lac) only, and Gold ornaments total 2 vories weight and also Silver ornaments, total 10 vories, Furnitures wooded double bed khat, dressing table, dining table with chairs and utensils as per demand of my Husband and my in-laws member.
- 3) That after one month of my marriage they started demanded more money from my parents, but my parents could not full fill their demand and as consequence all of them started tortured me physically and mentally. They assaulted me in every small matter and abusing me, but I always endure everything. My mother-in-law did not gave me proper food.

- 4) That this torture was continued but on 02.09.2021 the torture was took its extreme level, they poured Keorasin oil on my body and try to burn me but somehow I saved myself but they did not stop here and on 04.09.2021 they switched on LPG gas cylinder and opened its pipe and forcefully locked me into the room but survived but they locked me in my room so that I cannot made a complaint, again on 06.09.2021 they all together brake into my room and try to choked me with pillow. And they all beat me by fist and blows any kicked me, they hurt me so much that I was went to Siliguri District Hospital for cheek up. Then on 07.09.2021, I lodge a complaint in Siliguri(w) Police station. But after getting bail he approached to me that he wanted to live with me and our child.
- 5) That we started live separately in rented house in Samar Nagar, Battala, Dist- Darjeeling, few months it going well but after two-three months when my husband started visiting my in-laws house again they instigate him against me, and when he returned home he started abuse me beat me by fist and blows. And on 25.07.2023 he demanded Rs.2,00,000/- (Rupees Two Lac) only and a motor cycle.

Till now I tolerated everything but on 29.07.2023 in Maharam when I told my husband to took our child in Maharam, but he started getting angry for that and started talking about the 2,00,000/- rupees which he demanded earlier when I denied he hit me by "Lathi' in my leg and assaulted me then he throw me out from the house and locked the gate and when I tried to entered in the room he threatened me that if I enter into the room he will kill my son. I was so afraid then I went to my parent's house.

6) That today when I went to my in-laws home for some documents and also for my husband they did not listen anything and started abusing me and my son, when I resist against their abusive language they all together beat me and through me out from their home.

Therefore I request you to kindly take necessary step against the aforesaid culprits for the end of justice.
