Sir,

In producing herewith one arrested accused person namely Rohit Toppo (26) S/O Jale Toppo of Buraganj, Kuchiajote PS Phansidewa Dist. Darjeeling and seized one (01) Tractor having No. WB-73-E-9590 loaded with river bed materials i.e. stone chips as per seizure list.

In this regards I ASI Ashok Sarki of Bagdogra PS, SPC lodged a written complaint against the above noted arrested accused person to the effect that on 04.08.23 at 06-55 hrs myself alongwith C/522 Anil Barman, C/317 Kartick Roy were performed morning mobile duty vide Bagdogra PS GDE No. 160 dt. 04.08.23. At 07-25 hrs received a source of information that some loaded Tractor were seen with carrying river bed materials illegally from Taipoo river. Accordingly I informed the matter to duty Officer of PS and also O.C. Bagdogra PS and as per your direction myself alongwith force left for towards Taipoo river side and at 08-15 hrs reached at Khutipara near Taipoo river and found that the above noted Tractor loaded with riverbed materials was coming from Taipoo river side. I alongwith force intercepted the said tractor having No. WB-73-E-9590 at Khutipara near Taipoo river and apprehended the driver of the said tractor. On asked he disclosed his name and address mentioned above. During check the vehicle found that the said Tractor was loaded with riverbed materials i.e. stone chips. On demand the above noted apprehended driver failed to produce any documents/papers in favour of the carried substances (riverbed materials) and also failed to produce papers in support of the said vehicle. During enquiry it could be ascertained that the riverbed materials were loaded from Taipoo river illegally. Thus it is suspected that the organized racket in operation for carrying riverbed materials illegally for his wrongful gain and thereby causing huge revenue loss to the government of W.B. As such I seized the above noted Tractor loaded with riverbed materials i.e. stone chips with proper seizure list and arrested the driver of the said Tractor u/s 41 Cr.P.C. The seizure has been made in between 08-15 hrs to 08-55 hrs.

Under the above circumstances I pray that a specific case may kindly be started against the arrested accused person Rohit Toppo (26) S/O Jale Toppo of Buraganj, Kuchiajote PS Phansidewa Dist. Darjeeling and arrange for its investigation.
