Sir,

This is to inform you that I am the son of Bhagwan Das Agarwal, S/O. Late Dulichand Agarwal, resident of Green Valley Apartment, Block No.1, 2<sup>nd</sup> Floor, Ward No.43, upper Bhanu Nagar, of Siliguri Municipal Corporation. I have a shop at Golden Plaza, myself and my father carrying on business of shoes in the said Golden Plaza under the name and style "M/S Binay Footwear". We bring shoes mainly from Agra & other places. One Subhas Agarwal, S/O Late Banwarilal Agarwal, has also a shop at Golden Plaza which is situated adjacent to our shop and carrying on similar business.

Ankit Agarwal & Amit Agarwal, both S/O Hanuman Das Agarwal, both resident of Ganapati Apartment, Vidyasagar Road, Khalpara, ward No. 7, Siliguri, carrying on business from the shop of Subhash Agarwal, under the name and style "M/S Siliguri Footwear Pvt. Ltd".

The said Ankit Agarwal & Amit Agarwal used to create pressure to me not to purchase shoes from Agra & not to sell footwear goods to some of my particular customers who also purchase footwear from him. My father is aged about 70 years suffering from High Blood Pressure, diabetic and a man of religious mind who also sits in my business for some time in the morning and sometime in the evening. Ankit & Amit Agarwal who are desperate in nature always used to threaten me & my father without any rhyme & reason. About 4 months before, the said Ankit Agarwal assaulted me asking as to why I was

- purchasing footwear items from Agra & selling to some of his customer inspite of his direction.

It is to be mentioned that Ankit Agarwal & Amit Agarwal are my cousin brothers (sons of my mother's own sister). My aunty (Mausi) came to me & begged apology to me for her son Ankit as such I could not lodge any diary against him.

The said Ankit Agarwal , Amit Agarwal & their father are very jealous about our business as our business is running well and constantly by various means creating pressure not to purchase goods from Agra & to sell to some persons who mainly purchase shoes from us and from them also & their business is not running well. The matter was settled by the Association of Golden Plaza.

About 3 months back, it is unfortunate and unbelievable that Ankit Agarwal assaulted my father by fist & by kicks and their father Hanuman Das Agarwal also assaulted my father by shoes in presence of so many businessman of the Golden plaza and also in presence of some Police persons present there. It is to be mentioned that the said Ankit & Amit Agarwal & their father hatched up a conspiracy and I came to know that 3-4 days before the incident, they made a false diary to Khalpara Outpost by the wife of Ankit Agarwal.

Inspite of taking any action against the said Ankit Agarwal, Amit Agarwal & their father, my father and myself was taken to Khalpara Outpost by the police present there. It is to be mentioned that thereafter we were released from Police outpost as the allegation lodged by the wife of Ankit Agarwal is found to be false.

After 2 days the Committee of the Golden Plaza called a meeting and also called both of us, where Ankit Agarwal begged pardon to me & his father Hanuman Das Agarwal also begged pardon to my father coming to our house.



The office bearers of the Golden Plaza also came to our house and they took my father in Golden Plaza as my father due to shame he expressed that he would never go to Golden Plaza as he has been assaulted by Ankit Agarwal, Amit Agarwal & by his brother-in-law by shoe in presence of all the merchants and also falsely arrested by the police.

On 13.08.23 my father had been to attend a religious program organized by my aunty namely Babita Agarwal at Mayfair Residency, Jyotinagar, situated at ward No. 41. In the said program, the said Ankit Agarwal & his partners namely Subhash Agarwal & his family was also invited. While my father was about to come back with his car, Sri Ankit Agarwal suddenly made a hit on the chest of my father as a result of which he pushed back about 10 ft. and the people there saved him anyhow. The said Ankit Agarwal, s/o Hanuman Das Agarwal, Dimple Agarwal, w/o Subhas Agarwal, Dilip Agarwal, s/o Banwarilal Agarwal, Kiran Agarwal, w/o Dilip Agarwal, Rishab Agarwal, s/o Subhash Agarwal, all are resident of Panna Devi Niwas, behind City Plaza, Sevoke Road, Siliguri, all making criminal conspiracy with each other, made hit on the chest of my father with intention to kill him. Anyhow my father came back home and immediately he was shown doctor, as he was feeling bad. My father was admitted to Heritage Nursing Home yesterday evening as his condition was not good.

That the said Ankit Agarwal making conspiracy with Dimple Agarwal, Dilip Agarwal, Kiran Agarwal, Rishab Agarwal & others, hit on the chest of my father knowing fully well that he is a man of 70 years old, patient of High blood pressure & diabetic and by such hit on the chest he may die.

Sir, on the date of the incident I was in Kolkata and on the next day morning I rushed back to Siliguri by flight & I came to know in details.

It will not be out of place to mention that the said Ankit & Amit Agarwal always used to threat that he has command upon the political party and good relation with the Police administration and nobody can do anything to them. It

is also to be mentioned that the said Amit Agarwal also previously arrested in Gambling cases for running Casino illegally and was in jail custody for about a month. Both of them are desperate in nature and have no regard of Law and due to fear in fact I did not lodge any diary to the police authorities or did not take the shelter of Law.

Sir, myself is a very simple man & law abiding citizen & my father is a man of religious mind and we always try to avoid any quarrel & unpleasantness and as such I did not made any complaint before.

As I was out of station & was busy for the treatment of my father, there is a delay to lodge this complaint.

Now under the unavoidable circumstances I have been compelled to lodge this complaint. My father is in nursing home and fighting for life.

You are, therefore, requested to inquire into the matter & to take appropriate legal steps against the aforesaid persons in accordance with the law and save us.
