Respected Sir,

This is to inform you that I, Bablu Roy, Son of Late Chhatradhar Roy, am a resident of Thakur Nagar, Kamarvita, P.O. - Sahudangi Hut, District - Jalpaiguri. That yesterday at about 8:00 P.M. one person namely Rupak Ganguly, resident of Thakur Nagar, Kamarvita, P.O. - Sahudangi Hut, District - Jalpaiguri, came to our residence and asked my brother namely Krishna Roy, Son of Late Chhatradhar Roy to accompany him to Ashighar. That My said brother Krishna Roy along with the abovenamed Rupak Ganguly and his Brother-in-law namely Tapan went to Ashighar on a Motor Cycle (Avenger), bearing Registration No. WB 74 BG 5067. That after some time we came to know that my abovenamed brother namely Krishna Roy was brutally injured and he was lying unconscious near Dhakeshwari More. That upon hearing such news we rushed to the spot and found our brother namely Krishna Roy, lying on the road and huge amount blood was spilling out from his head and his head was badly injured. That there was no trace of the abovenamed Rupak Ganguly and his Brother-in-law namely Tapan, who had taken him to Ashighar. That thereafter we took my brother namely Krishna Roy to Siliguri District Hospital, but taking into consideration his injury he was referred to North Bengal Medical Collage and Hospital, but even there he was not kept and looking into his medical condition, my said brother was referred to some good nursing home. That thereafter we took the said Krishna Roy towards one private nursing home in Siliguri, but the said Krishna Roy passed away before we could reach there. That subsequently we brought the said Krishna Roy back to North Bengal Medical Collage and Hospital where he was declared dead. That it is pertinent to mention here that my brother namely Krishna Roy (now deceased), Rupak Ganguly and Tapan worked together and they dealt in land matter, and recently there was some conflict going on with regard to some financial transaction in between my deceased brother Krishna Roy and the abovenamed Rupak Ganguly and Tapan. That after the demise of my deceased brother namely Krishna Roy, we went to visit the house of both Rupak Ganguly and Tapan to know about how my brother received such brutal injury on his head, but both Rupak Ganguly and Tapan were not at their home and till now they are absconding. That from the abovementioned circumstances it is extremely clear that the abovenamed Rupak Ganguly and Tapan out of their grudge and anger have conspired and killed my brother namely Krishna Roy.

Hence I pray before your goodself to kindly look into the abovementioned matter and take necessary actions against the abovementioned Rupak Ganguly and Tapan as per the due course of Law for the administration of Justice.
