I, Smt. Gita Das, Wife of Binod Das, resident of 2No Panchanan Colony, Ward No. 1 of SMC, P.O. & P.S. Pradhan Nagar, Dist Darjeeling, am writing this complaint to the very effect that on last week one Md Shoaib, son of not known, resident of Bucchar Patty, Old Matigara Road, Gate Bazar purchased mobile accessories worth amount of Rs. 1,000/- from my son's shop which is situated at the road end beside Bani Mandir Railway High school, Gate Bazar at Ward No. 1 of SMC, on outstanding debt basis on assurance to disburse the amount by yesterday ie. 18/08/2023. Thereafter on yesterday ie. 18.08.2023 at around 8.40 PM the said MD Shoaib along with his elder brother namely MD Shahid and 5-6 other associates visited my son's shop and on query of disbursement of his said debt, he denied to return so and further threatened my son to give of Rs. 10,000/- cash as Gunda tax for running the shop, on my son's refusal the above Md Shoaib, his elder brother Md Shahid and others attacked my son, it appeared that the said MD Shoaib and his associates were armed with iron rods, knifes, wooden sticks etc. started to beat my son mercilessly as referred to be attempt to murder my son and on my son's shouting, my another son namely Bishal Das who was at that moment went near to our shop for getting tea, rushed at the shop and tried to resist them, also had been assaulted physically by the above antisocial mercilessly. My son received severe bodily injuries including serious fatal injury at forehead, blood clots at too many parts of body and even my another son got serious injuries. It is also to be referred that during such situation, the above antisocial snatched my son's gold neck chain and took Rs. 12,000/- cash from my son's pocket. On my son's shouting, the local people rushed at the spot and the above culprits left the spot with threatening to my son's under dire consequences if there said extortion money demand should not be complied. Out of said attack, My son namely Abhishek Das was admitted at Siliguri Dist Hospital under serious condition (Medical documents enclosed herewith) and right now I along with my family members are living under the panic of being harmed to our life and limb by the said Md Shoaib, Md Shahid and others, these antisocial shall have to be punished for their said act of attempt to murder my son as they had no regard to the law of the land.

So, It is the need of the hour to take appropriate legal action against the above named persons Md Shoaib and Md Shahid and others for the proper administration of Justice.
