- 5. That in this way the said the said RAJU ALAM along with NURJAHAN BEGUM, W/O Raju Alam, 2. NAJRUL ISLAM, father of Raju Alam, received a total sum of Rs. 32,00,000/- (Rupees Thirty Two Lakhs Only) from the persons on different dates as per the accounts of various persons by way of illegal means and by misusing his official capacity.
- 6. That subsequently when it came to my acknowledge that the said RAJU ALAM along with NURJAHAN BEGUM, W/O Raju Alam, and NAJRUL ISLAM, father of Raju Alam, we resisted to re-new the said Agreement dated 25.05.2022 for further tenure as a result the said RAJU ALAM along with NURJAHAN BEGUM, W/O Raju Alam, 2. NAJRUL ISLAM, father of Raju Alam, lost all their rights and authorities to run the Kiosk Operations in any way whatsoever.
- 7. That after that I received one Written Complaint from one Jahirul Haque, S.O., Azizul Rahaman, who is a CSP Operator of Changrabandha being Operator Code No. 32311035 wherein the said person complaint that the said RAJU ALAM along with NURJAHAN BEGUM, W/O Raju Alam, 2. NAJRUL ISLAM, father of Raju Alam and some anti- social persons came to his CSP, situated at Changrabandha and withdraw a huge amount of money from various clients Account by putting gun on his head and for that the said

- Jahirul Haque, S.O. Azizul Rahaman, incurr a huge lost and Jahirul Haque, S.O., Azizul Rahaman finding no other alternative, he had to deposit the said extorted amount to Goshaihat Branch Account.
- 8. That by taking the biometric of various customers, by way misrepresentation fraud, the said RAJU ALAM along with NURJAHAN BEGUM, W/O Raju Alam, 2. NAJRUL ISLAM, father of Raju Alam, succeeded to misappropriate huge amount of Money which was being withdrawn from the various accounts of the customer, even without their acknowledgment and consent.
- 9. That after that some of the customers out of the said List namely Sabita Sarkar being Account Holder No. 35759695262, Kohinoor Uncesha Account Holder No. 35929601952, Bisnupriya Majumder Account Holder No. 3577353289 filed a Complainant before me on various dates stating that from their accounts considerable amounts has been withdrawn by the said RAJU ALAM along with NURJAHAN BEGUM, W/O Raju Alam, 2. NAJRUL ISLAM, father of Raju Alam without their consent and acknowledgment.
- 10. That the said RAJU ALAM along with NURJAHAN BEGUM, W/O Raju Alam, 2. NAJRUL ISLAM, father of Raju Alam undertakes that he had received the customer money without the consent of the said customers and also transferred the same to his bank account with a prayer that he will repay the aforesaid amount within one month, but even after the lapse of the said date the said RAJU ALAM along with NURJAHAN BEGUM, W/O Raju Alam, 2. NAJRUL ISLAM, father of Raju Alam did not refund the said amount to the above mentioned persons.
- 11. That subsequently after getting the knowledge of the same we have taken the necessary action against him by terminating his service as well as code and in this regard we have also requested the said RAJU ALAM along with NURJAHAN BEGUM, W/O Raju Alam, 2. NAJRUL ISLAM, father of Raju Alam and also instructed the said RAJU ALAM along with NURJAHAN BEGUM, W/O Raju Alam, 2. NAJRUL ISLAM, father of Raju Alam to remove all the posters. In this way with an intention to misappropriate the public money the said RAJU ALAM along with NURJAHAN BEGUM, W/O Raju Alam, 2. NAJRUL ISLAM, father of Raju Alam has misused his official capacity to transfer the said amount of Rs. 32,00,000/- (Rupees Thirty Two Lakhs Only) to his account illegally.

- 12. That the said RAJU ALAM along with NURJAHAN BEGUM, W/O Raju Alam, 2. NAJRUL ISLAM, father of Raju Alam and also instructed the said RAJU ALAM along with NURJAHAN BEGUM, W/O Raju Alam, 2. NAJRUL ISLAM, father of Raju Alam, also withdraw money from various accounts of various person as per the list mentioned above by way of using various expired ATM cards which were issued in the name of various customers, but the above named culprits practicing some fraud technicalities, successfully using those ATM cards of the customers and misappropriated huge amount of money.
- 13. That by this way the said RAJU ALAM along with NURJAHAN BEGUM, W/O Raju Alam, 2. NAJRUL ISLAM, father of Raju Alam who is in capacity of a public servant commits criminal breach of trust in respect of the property.
- 14. That the said RAJU ALAM along with NURJAHAN BEGUM, W/O Raju Alam, 2. NAJRUL ISLAM, father of Raju Alam also cheated the valuable security/money of public in general which he was entrusted in such capacity of C.S.P. operator commits criminal breach of trust in the said aspect and also by way of this the said RAJU ALAM along with NURJAHAN BEGUM, W/O Raju Alam, 2. NAJRUL ISLAM, father of Raju Alam commits forgery for the purpose of cheating to the public in general as well as to our society.
- 15. That the above named persons have therefore committed the offence of cheating and criminal breach of trust in hatching up a deep rooted conspiracy with the ulterior motive of defrauding me and causing wrongful loss to me in every aspect
- 16. That finding no other alternative we on various occasions approached to the said RAJU ALAM along with NURJAHAN BEGUM, W/O Raju Alam, 2. NAJRUL ISLAM, father of Raju Alam to repay the said amount of Rs. 32,00,000/- (Rupees Thirty Two Lakhs Only) but he refused to do so.

I therefore request before your good self to kindly look into the matter and take necessary action against the aforesaid accused person as per the provision of law to recover the public money and for this act of kindness I shall remain extremely greatfull to you.
