Sir,

With due respect, I am producing herewith the arrested accused persons namely (i) Ananda Sarkar (28yrs) S/O Ganesh Sarkar of tinbatti colony, Ps- NJP, Dist- Jalpaiguri (ii) Rahul Yadv (22yrs) S/O Lt Laxman Yadav of Rajaholi, W/N 35, Ps- NJP, Dist- Jalpaiguri (iii) Sanjoy Ojha (27yrs) S/O Lt Bimal Krishna oja of Fulbari berradge, Juggivita, PS-NJP, Dist- Jalpaiguri (iv) Aminul Mohammad (24yrs) S/O Abjal mahammad of murder more, paschimdhantala, PS-New Jalpaiguri, Dist- Jalpaiguri (v) Sayed Ali (18yrs) S/O Ramjan Ali of murder more, paschimdhantala, PS-New Jalpaiguri, Dist- Jalpaiguri and the following articles under seizure :-

1. One Iron Rod and Screw Driver, One Range and One Blunt Iron Rod measuring 30 CM in length from the possession of accused Ananda Sarkar (28yrs) S/O Ganesh Sarkar of tinbatti colony, Ps- NJP, Dist- Jalpaiguri.
2. One Bhojali and Torch Light and Small Iron Road from the possession of accused Rahul Yadv (22yrs) S/O Lt Laxman Yadav of Rajaholi, W/N 35, Ps- NJP, Dist- Jalpaiguri.
3. One Torch Light and Knife and one hauswa from the possession of accused Sanjoy Ojha (27yrs) S/O Lt Bimal Krishna oja of Fulbari berradge, Juggivita, PS-NJP, Dist- Jalpaiguri
4. One Iron Rod and One Torch Light measuring about 30 Cm from the possession of Aminul Mohammad (24yrs) S/O Abjal mahammad of murder more, paschimdhantala, PS-New Jalpaiguri, Dist- Jalpaiguri.
5. One Knifre and One Hammer from the possession of accused namely Sayed Ali (18yrs) S/O Ramjan Ali of murder more, paschimdhantala, PS-New Jalpaiguri, Dist- Jalpaiguri.

I, SI-Pradeep Diyali of New Jalpaiguri PS, Siliguri Police Commissionerate beg to state that on 22.08.2023 at 0125 hrs I received a secret source information that a gang of miscreants come to Madani Bazar, behind Menati Medical Shop, PS- New Jalpaiguri, Dist- Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Madani Bazar and baribhasa Area. Accordingly, I informed the fact to you and diarized the fact in General diary vide NJP PS GDE No-1108/23 dated 22.08.2023. As per kind order myself along with VP/13 Jamirul Islam, C/453 Uttam Dey, C/1044 Hari Kherwar all are of New Jalpaiguri PS, Siliguri Police Commissionerate left for Madani Bazar, PS-New Jalpaiguri, Dist- Jalpaiguri to work out the information in hand. I also informed the fact to night RT Van officer ASI Pranab Majumdar of New Jalpaiguri PS, Siliguri Police Commissionerate along with force and directed him to come to Madani bazar to accompany with us. At about 0145 hrs on 22.08.2023 we arrived at Madani Bazar PS-New Jalpaiguri PS, Siliguri Police Commissionerate. After a while ASI Pranab Majumdar along with force came to Madani Bazar, and accompany with us. After arrival of the spot and as identified by the source we found that 10/11 persons assembled in a dark place at Madani Bazar under New Jalpaiguri PS, Dist- Jalpaiguri and they were whispering in a very low voice. Accordingly we cordoned the place properly and approach towards them very slowly and carefully. But seeing the police party they started to flee away but we the police party managed to apprehended 05 (Five) of them. On interrogation the apprehended accused persons disclosed their name and identity as noted above and also disclosed that they assembled there to commit dacoity in a house at Madani Bazar area. They also stated that others 06/07 associates were able to fled away from the spot by taking advantages of darkness. On search of the apprehended accused persons found (i) One Iron Rod and Screw Driver, One Range and One Blunt Iron Rod measuring 30 CM in length from the possession of accused Ananda Sarkar (28yrs) (ii) One Bhojali and Torch Light and Small Iron Road from the possession of accused Rahul Yadv (22yrs) (iii) One Torch Light and Knife and one hauswa from the possession of accused Sanjoy Ojha (27yrs) (iv) One Iron Rod and One Torch Light measuring about 30 Cm from the possession of Aminul Mohammad (24yrs) (v) One Knifre and One Hammer from the possession of accused namely Sayed Ali (18yrs). During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night. Finally they admitted their guilt and disclosed that they had assembled there and taking preparation for committing dacoity in a house at madani bazar and Baribhasa Area. Accordingly, I seized the above noted articles under proper seizure list and arrested the above noted 05 (Five) accused persons under proper memo of arrest and observing all the formalities of arrest. The search seizure and arrest made in between 0245 hrs to 0345 hrs on 22.08.2023

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely ((i) Ananda Sarkar (28yrs) S/O Ganesh Sarkar of tinbatti colony, Ps- NJP, Dist- Jalpaiguri (ii) Rahul Yadv (22yrs) S/O Lt Laxman Yadav of Rajaholi, W/N 35, Ps- NJP, Dist- Jalpaiguri (iii) Sanjoy Ojha (27yrs) S/O Lt Bimal Krishna oja of Fulbari berradge, Juggivita, PS-NJP, Dist- Jalpaiguri (iv) Aminul Mohammad (24yrs) S/O Abjal mahammad of murder more, paschimdhantala, PS-New Jalpaiguri, Dist- Jalpaiguri (v) Sayed Ali (18yrs) S/O Ramjan Ali of murder more, paschimdhantala, PS-New Jalpaiguri, Dist- Jalpaiguri and others and arrange for its investigation..
