## SUB: FIR

Respected Sir,

I, SI Ramanath Karjee presently posted at Siliguri PS, SPC beg to report before your kind self that today on 22.08.2023 during my mobile van duty of K-22 evening mobile van vide MCC No.1880, date: 22.08.2023 which refers to Siliguri PS GDE No. 955, dated: 22.08.2023 received a telephonic from table duty officer of Siliguri PS at about 16:05 hrs that a chaos is going on at Siliguri Court Complex (under Siliguri PS) which refers to Siliguri PS GDE No. 969, dated: 22.08.2023. Immediately myself along with force had been to the Siliguri Court and found a huge number of unruly crowd (approx 50-60 male and female persons) showing protest regarding the production of an accused person named Md. Abbas, s/o- Md. Vhadu of Lenin Colony, Matigara, PS-Matigara, Dist- Darjeeling who was arrested in c/w the Matigara PS case no. 682/23, date: 21.08.2023 u/s- 302 IPC. The mob led by Ajay Singh, Amit Gupta, Pratima Joshi and others leaders of Viswa Hindu Parishad and Bajrang Dal, Siliguri (Darjeeling) wing tried to lynch the arrested accused person from the custody of the I/O SI Paresh Barman of Matigara PS/SPC prior to his production before the Ld. Court. Immediately myself along with the Court Inspector Shri Mihir Das, I/C, Women PS, Siliguri Mumtaz Begum, O/C, Panitanki TOP SI Pappu Singh, SI Amartya Chakraborty, SI Tushar Kanti Mandal, SI Kamal Biswas, PSI Biplab Sen, PSI Biplab Barman all of Siliguri PS along with force tried to prevent them from taking law in their own hand. The unruly mob immediately started scuffling with the police personnel on duty and assaulted them to deter them from discharge of their Government duties. They also started pelting stones on the police team causing injuries to them. Somehow the police team managed to save the arrested accused person from the clutches of the unruly mob and managed to produce him before the Ld. Court safely.

In this regard I therefore pray before your kind self to start a specific case under

proper section of law kindly arrange for its investigation.
