I, SI Kamal Biswas presently posted at Siliguri PS, SPC beg to report before your kind self that today on 23.08.2023 during my mobile van duty of CS I morning mobile van vide MCC No.1885, date: 23.08.2023 which refers to Siliguri PS GDE No. 1005, dated: 23.08.2023 received a telephonic from table duty officer of Siliguri PS at about 11:35 hrs that a chaos is going on at Siliguri Airview More (under Siliguri PS) which refers to Siliguri PS GDE No. 1013, dated: 22.08.2023. Immediately myself along with force had been to the Siliguri Airview more and found a huge number of unruly crowd (approx 100-150 male and female persons) showing protest demanding death penalty for an accused person named Md. Abbas, s/o Md. Vhadu of Lenin Colony, Matigara, PS- Matigara, Dist- Darjeeling who was arrested yesterday in c/w the Matigara PS case no. 682/23, date: 21.08.2023 u/s- 302 IPC. They tried to stop the free flow of traffic at Airview more then I/C Siliguri PS along with ACP East I requested them to clear the traffic congestion. But in spite of several reminders they sat on the open road and on further announcement they blocked the road. Then police team tried to console them as there was traffic congestion, at this point the unruly mob immediately started scuffling with the police personnel on duty including the lady police personnel and assaulted them to deter them from discharge of their Government duties. They also started pelting stones on the police team causing injuries at various degrees to the on duty Police. Meanwhile they damaged the Police Vehicles and Govt. properties and tried to set on fire and disrupted the public peace and tranquility of the locality and they also tried to mobilize minor children from different schools of Siliguri in this unruly protest.


