With due respect I, **SRI KAJAL CHAKRABORTY**, Son of Late. Satyendra Chakraborty, Resident of Near Bas Jhar More, ISKCON Road, 2 No. Jyoti Nagar, P.O. Sevoke Road, P.S. Bhaktinagar, District – Jalpaiguri in the State of West Bengal, would like to lodge this Written Complaint before your good office to the effect that I am a Senior Citizen and my wife died in the year of 2015 due to stroke and presently I am totally dependent upon the income from the household rent of the above mentioned address.

Sir, I have a son namely Sri Sanjib Chakraborty (Barun), aged about 32 years old who also resides with me at my house situated at the above mentioned address. It is to be mentioned here that my above mentioned son is a very short tempered man and since the days of his college days he used to assault me without any reason and he also used to blackmail me by many ways.

Sir, in the year of 2019 my son above mentioned has assaulted me badly and he attacked upon my stomach by knife and as a result I was injured badly and I was admitted to Siliguri District Hospital and thereafter I was shifted to NBMC&H and ultimately I was admitted to Anandloke Hospital, 2<sup>nd</sup> Mile Sevoke Road, P.S. Bhaktinagar, District- Jalpaiguri and after 2 to 3 months I was discharged by the hospital.

Sir, it is to be mentioned here that my above mentioned son does not do any kind of work / job and he waste his time in an idle mode and doesn't work or earn a single penny and on the other hand, I have to look after his wife and minor son from my limited income from household rent.

Sir, on 17.08.2023 I went to Kolkata for my personal work and I came back 22.08.2023 I returned back to my house and found that my above mentioned son has broken the lock of the Wooden almirah and stolen away my 5-6 files which were containing my Deed of Land and all other papers and he also stolen away cash of Rs. 23,000/- from the above mentioned Almirah and when I asked him as why he has done the same and when I request him to give back the papers of my property and other medical documents etc. he flatly denied to give it back and he is continuously saying that he will not give back the files and cash, moreover he will capture the house and oust me from the same.

Sir, today some of my relatives came to settle the matter peacefully and they asked my son why he is doing all these things, at this he started to abuse the relatives with very filthy and offensive language and he also threatened that he will kill me as soon as possible as I was rescued by the doctors last time but this time my son will kill me and capture entire property.

Sir, I am in great fear that my above mentioned son will kill me whenever he get the chance and he has intentionally stolen the files and cash from my Almirah.

I, therefore being a old aged senior citizen, fervently requesting you to look into the matter properly and please take
