With due respect, I Smt. Suman Balmiki, D/o Sri Suresh Balmiki, resident of Ganganagar,

M.G. Road, near Star Point School, Vindi Khet, S.M.C Ward No - 5, P.O - Siliguri Bazar, P.S - Siliguri, District - Darjeeling, would like to inform you that since the day of marriage of my uncle Sri Dipak Balmiki, S/o Late Dwarika Prasad Balmiki, resident of Ganganagar, M.G. Road, near Star Point School, Vindi Khet, S.M.C Ward No - 5, P.O - Siliguri Bazar, P.S - Siliguri, District - Darjeeling and his wife Smt. Arati Balmiki who is my aunt in relation and one Smt. Anita Balmiki, the mother of Arati Balmiki and Sagar Balmiki, the brother of Arati Balmiki, resident of Jalapahar, Army Camp, P.S - Jorbunglow, District - Darjeeling are threatening me with dire consequences without any authentic reason and whenever I have raised my objection, they used to abuse me in filthy languages with threatening to murder me.

Date - I used to overlook their abuses and threatening for the peace and tranquillity in the family but on 23.8.23 9-8-2023 in the morning at about 10 hrs, my uncle Dipak Balmiki kicked the gate of my house and said and when I have raised my objection, he started threatening me to see me and returned back to his house with filthy abuses and on the same day i.e. 9-8-2023 at about 1.30 p.m. all of a sudden my uncle Dipak Balmiki and aunty Smt. Arati Balmiki and her mother Anita Balmiki and brother Sagar Balmiki who came from Darjeeling have started abusing me and my other family members in filthy languages and when I have raised my objection, the said Dipak Balmiki and his brother in law Sagar Balmiki have started assaulting me and to disrobe my modesty and have torned my cloths and have touched my private parts and the said Arati Balmiki and Anita Balmiki have consistently assisted and induced them to commit rape upon me by holding my heirs. In the mean time, the said Arati Balmiki has snatched my gold chain from my neck weighting about 15 grams and after raising my hue and cry when the neighbours and my other family members came, they have fled away with threatening.
