Darjeeling to the effect that today on 30.08.2023 at 19.05 hrs received a source information that one person has been selling huge illegal liquor at Babua hotel, Regulated market under Pradhan Nagar Police Station without any valid license. Accordingly I informed the matter to the I/C PS and as per his kind direction I along with CV/646. Baban Das and CV/992 Jagadish Biswas ( All of Pradhannagar Ps) had been to Regulated market under Pradhan Nagar PS to verify the veracity of source information vide Pradhannagar ps GDE no. 1680, Dt. 30.08..23. Debendra Mandal of Dhaknikata Murgi Math, Ps. Pradhannagar, Dist. Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 19.15 hrs to 19.45 hrs at the spot and arrested him after informing the ground of arrest.
