Subsequently, after sharing the information with my superiors and as pe direction, I along with ASI Pema Dorjee Sherpa C/523 Sanjit Kundu and C/219 Sa Chitrakar, all of Matigara PS, SPC, left for the place to work out the information. At about hrs after reaching near Goyal More under Matigara PS, I met my source and being poin the source we started walking towards Goyal More. At 00:55 hrs we reached at Goyal Mo started cordoning off the suspected persons as shown by the source with a strong rea believe that they were preparing to commit some cognizable offence and were about to from the spot. Seeing police personnel approaching towards them they tried to flee away, hot chase we managed to apprehend above noted 05 (five) accused persons along with articles as mentioned above. However, the other persons managed to flee away from the taking the advantage of darkness. On interrogation all the accused persons admitted that had assembled there to commit dacoity in a house near Goyal More.
