Sir,

In producing herewith one accused person named Harish Sen (43) S/o Jogesh Chandra Sen of New Pokhajibote, Champasari, PS Pradhan Nagar, Dist. Darjeeling under arrest along with following articles under proper seizure.

Total of 14 bottles of Strong Beer styled as 'KINGFISHER', each bottle containing 650 ml, having price Rs. 135 each, total of 9.1 liters, out of which one bottle taken as sample for examination.

I, ASI Biplab Kumar Das of Pradhan Nagar Police Station under Siliguri Police Commissionerate would like to lodge this written complaint against one accused person named Harish Sen (43) S/o Jogesh Chandra Sen of New Pokhajibote, Champasari, PS Pradhan Nagar, Dist. Darjeeling to the effect that today on 31.08.2023, while performing mobile van duty received a source information at around 22:15 hrs. that one person has been selling huge quantity of illegal liquor at his shop styled as Subham Hotel at Champasari main road under Pradhan Nagar Police Station without any valid license.

Accordingly, I informed the matter to the I/C PS and as per his kind direction I along with CV/223 Swapan Chettri and CV/128 Ajay Kr. Sahani had been to the shop of the above mentioned accd. person at Champasari main road under Pradhan Nagar PS to verify the veracity of source information. On reaching there and as identified by the source found that the above-mentioned person was selling openly at Subham Hotel, Champasari main road under Pradhan Nagar PS, SPC.

Subsequently, I along with my force was able to detain the above noted person. Subsequently on being asked the apprehended person disclosed his name and identity as noted above. On demand he failed to produce any valid license/papers for selling and storing of such articles. On further interrogation he stated that he is involved in selling and possessing of liquor without any valid license for last 06 (six) months for his illegal gain.

Then I seized and labeled the above mentioned illegal liquor under proper seizure and arrested the above-mentioned person named Harish Sen (43) S/o Jogesh Chandra Sen of New Pokhajibote, Champasari, PS Pradhan Nagar, Dist. Darjeeling after observing all sorts of formalities at the spot. The whole process of seizure and label has been made in between 22:25 hrs. to 22:45 hrs. at the spot and arrested him after informing the ground of arrest.

I, therefore pray before your good self that a specific case may kindly be initiated against Harish Sen (43) S/o Jogesh Chandra Sen of New Pokhajibote, Champasari, PS Pradhan Nagar, Dist. Darjeeling under proper section of law and may arrange to cause its investigation for violation of rules and norms of Bengal Excise Act.
