With due respect, in producing herewith one lady accused person namely Sabita Thakuri (F/30 years) W/O- Ramesh Thakuri of Kholachand Papri Near Football ground P.S- Bhaktinagar, Dist-Jalpaiguri along with the following seized articles as per proper seizure list:

1. 28 (Twenty Eight) bottles of KINGFISHER strong Beer each bottle containing 650 ML.
2. 12 (Twelve) bottles of Royal Blue premium whisky each bottle containing 375 ML.

With due respect and humble submission, I PSI Koushik Raha of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodge this written complaint after producing herewith the above noted seized articles to the effect that on 31.08.23 at 12.35 hrs while performing PS mobile van duty received a source information that one lady namely Sabita Thakuri is selling liquor from her house without any documents/license for wrongful gain situated at Kholachand Papri Near Football ground under Bhaktinagar PS/SPC. Discreased the fact in GD vade Bhaktinagar PS GDE No- 1648, dated 31.08.23. As per kind instruction of superior myself along with SI Mrinal Basunia, SI Rantu Haldar, ASI Chandra Prakash Adhikary, L/C 1348 Menuka Rana, L/C 1584 Rupni Orrown, C/374 Debraj Biswas proceeded to the PO to work out the information. At 13.05 hrs we reached at the spot being identified by the source our police party held raid at the house of above accused person and was able to detain her who disclosed her identity as noted above. On being searched we recovered the above noted articles from her house. On demand she failed to produce any valid documents or licence in respect of the illegal liquor. On being asked she confessed her guilt and stated that she is selling the liquor from her house since long for her wrongful gain without any valid documents/license. I seized the above noted articles from the PO after preparing proper seizure list in presence of witnesses (The seizure was made in between 13.45 hrs to 14.25 hrs). As she has violated the rules and norms of Bengal Excise Act hence, I arrested the apprehended accused lady namely Sabita Thakuri (F/30 years) W/O- Ramesh Thakuri of Kholachand Papri Near Football ground P.S- Bhaktinagar, Dist-Jalpaiguri after observing all sorts of formalities u/s 41 Cr.P.C appraising her the ground of arrest.

I therefore request you a specific case may kindly be start against the accused person namely Sabita Thakuri (F/30 years) W/O- Ramesh Thakuri of Kholachand Papri Near Football ground P.S- Bhaktinagar, Dist-Jalpaiguri under proper section of law and arrange for investigation.
