Sir,

In producing herewith one accused person namely Dipesh Tamang-35yrs s/o Prem Bahadur Tamang of 32 No, near Ranipool, PO+PS Ranipool Dist –East Sikkim, Sikkim in custody and the following property under seizure along with seizure list:-

i. 18 strips of Nitrazepam tablets IP 10mg each strips containing 10 tabs total-

180 pcs, Marked As Exhibit A

ii. 333 (Three hundred thirty three) Strips of WNISPASMO forte capsules (Tramadol Acctaminophen & Dicyclomine HCL capsules) each strips containing 08 Capsules total 333x08= 2664 Capsules. Marked As Exhibit B

- iii. 19 (Nineteen) Bottles of ALTOREX-CD Cough Syrup Composition with Codeine phosphate & Chlorpheniramine Malcate IP 10 mg each bottle containing 100 ML total weight 19X100 Ml= 1.900 Ltr Marked As Exhibit C
- iv. One realme mobile phone having IMEI No-869795058487419/01
- v. One Black colour school Bag in which Seized article (Sl No- i,ii, iii) was kept inside the bag.

I, PSI Koushik Raha S/O- Jitendra Raha of Bhaktinagar PS/ SPC do here by lodged this complaint to the effect that on 02.09.23 at 17.45 hrs received a secret reliable source information that one person having possession of huge quantity of Narcotics Substances in his possession without valid documents and selling to the addicted young boys at Roy car parking, Eastern bypass opposite Monokamona Flour Mill under PS- Bhaktinagar. Accordingly the information was diarized vide BKN PS/SPC GDE No. 71 Dtd. 02.09.23 and informed with a written letter to the I/C Bhaktinagar PS/SPC about this information. As per kind order of I/C Bhaktinagar PS/SPC myself along with, SI Srimanta Chatterjee, SI Mrinal Basunia, PSI Chiranjit Saha, ASI Dipak Karmakar, ASI Chandra Prakash Adhikary, Const/ 374 Debraj Biswas and C/1426 Prasanta Kumar Dutta all of Bhaktinagar PS/SPC left by govt. vehicle vide BKN PS/SPC M.C.C No-1454/23 Dt. 02.09.23 to verify the veracity of information corresponding BKN PS/SPC, GDE.NO. 72 Dated. 02.09.2023 At the time of departure from Bhaktinagar PS I bring digital weighing machine, envelope, white paper, sealing wax, gum, seal etc. At about 18.10 hrs on arrival there I called two disinterested witnesses from the spot who were present & available there at that time namely (i) Manish Bansal s/o Binod Bansal of Dasarathpally, PO Sevoke road ward No-44, P.S- Bhaktinagar, Dist- Jalpaiguri(9832378850) and (2) Uttam Roy s/o Gopal Roy of Roy colony Chayanpara PS Bhaktinagar Dist Jalpaiguri(8617822487) also disclosed the matter regarding our information. I also requested them by issuing a written letter for their Consent to accompany us in the whole process during search and seizure if necessary, and obtain necessary permission of their presence as witnesses in the entire process of Search and Seizure under relevant provision of law as witness. At about 18.20 hrs as shown and identified by the source, we found one person was standing at Roy car parking, Eastern bypass opposite Monokamona Flour Mill under PS-Bhaktinagar with one black colour school bag and we detained the above noted person along with above noted articles which was kept in his back side. We disclosed him our identity as police personnel. On being asked he disclosed his identity as noted above. On further examination the above alleged person stated that he is carrying and possessing "Narcotics Substances" with him. Then I asked him whether he wanted to be search in presence of an Executive Magistrate or any Gazetted Officer and he agreed to search by any one. I served him

a notice in accordance with provisions of law in this regards. I also offered the independent Witnesses and apprehended person to search our Police Party as per provision. But they refused to search by the police party. Then I informed the matter to special Executive Magistrate and requested him to come at Roy car parking, Eastern bypass opposite Monokamona Flour Mill to remain present and supervise the search and seizure as he being a special Executive Magistrate. After some time Special executive magistrate Shree Maksadur Rahaman ACP/SPC & ICP Fulbari/SPC arrived at the spot. I disclosed the identity of Shree Maksadur Rahaman ACP/SPC & ICP Fulbari/SPC to the apprehended person and witnesses as a Special executive magistrate. Thereafter under the supervision of Shree Maksadur Rahaman ACP/SPC & ICP Fulbari/SPC and in presence of him and independent witnesses I conducted search of the above apprehended person keeping strict regard and found the articles as per seizure list in a school bag which was possessing/carrying by the apprehend person. On being asked he further confessed in presence of Special executive magistrate and other witnesses that he procured the Narcotics Substance clandestinely for the purpose of selling to his designed Customers in order to earn huge amount of money for his wrongful gain. On interrogation he disclosed that he has been dealing in such illegal drug trafficking business and selling the same to the adjacent area of Bhaktinagar PS and Hill side also. On examination of the alleged apprehended person noted above regarding any documents for carrying/possessing of said Narcotics Substance he failed to produce any documents or license in support of possessing of such drugs. Then as per direction of Shree Maksadur Rahaman ACP/SPC & ICP Fulbari/SPC) I seized the articles under proper seizure list and Label under the supervision of Shree Maksadur Rahaman ACP/SPC & ICP Fulbari/SPC in presence of witnesses duly signed by them as well as the accused person and marked the seized exhibits as noted above.

The seizure and label was made between 19.40 hrs to 21.20 hrs. The whole process of search and seizure was video graphed by the videographer Sri Nitai Chowdhury of Shivarampally,

Haiderpara PS Bhaktinagar Dist Jalpaiguri.

Then I arrested the above noted accused person u/s- 41 Cr.P.C after observing all formalities of arrest and disclosed them cause of arrest issuing necessary Memo of Arrest. The copy of seizure list and Memo of Arrest was supplied to above noted alleged person under proper receipt as the alleged accused person violated the terms and condition of N.D.P.S Act possessing cough syrup and capsules, tablets without any lawful documents.

Under the above circumstances, I pray to you that a specific case may kindly be started against the accused person namely Dipesh Tamang-35yrs s/o Prem Bahadur Tamang of 32 No, near Ranipool, PO+PS Ranipool Dist -East Sikkim, Sikkim and arrange for its investigation.
