Sub: Handing over of One BD national for fraudulently procuring Indian Passport and Indian ID's.

Sir,

In producing here with one Dilip Kumar Bhowmik, S/o Lt. Monomohan Bhowmik BD national to the effect that on 27.08.2023 at about 17:30 hrs. he arrived at Fulbari ICP, Siliguri Police Commissionerate attempting to depart to Bangladesh.

During immigration clearance it was notice that the above subject is originally a Bangladeshi National (by birth) and both of his parents are Bangladeshi national since dead. He claimed to initially entered India in 1991 illegally through Tripura Border, India and procured a piece of land in West Bengal in 1996. He managed to procure Indian Voters Card no. WDB1315522, Addhaar Card no. 732496630540, PAN CARD NO. AJWPB0662N and Indian Passport nos. i) U371475 ii) E6669540 iii) G2321169 iv) Z2523797 v) X6492053 by fraudulently means.

The following articles were seized from his possession A) Xerox copy of Bangladeshi National ID Card in the name of Dilip Kumar Bhowmik having ID No. 6725803454288. B) Xerox copy of Indian Voters Card no. WDB1315522, Addhaar Card no. 732496630540, Pan Card no. AJWPB0662N C) Original Indian Passport nos. i) U371475 ii) E6669540 iii) G2321169 iv) Z2523797 v) X6492053 D) Self Deceleration Letter by Dilip Kumar Bhowmik Dt. 27.08.2023.

Hence, I seized the above noted articles from Dilip Kumar Bhowmik, a Bangladesh National in presence of witnesses u/s 102 Cr. P.C. and arrested him u/s 41 Cr. P.C. I handed over them to O/C New Jalpaiguri P.S. under SPC for legal action as per law.
