Respected Sir,

In producing herewith two (02) arrested lady accused persons namely (i) Gouri Debnath (F/55) w/o Shyamal Debnath of Jamuri Vita, 1. No. Fulbari, PS NJP, Dist. Jalpaiguri (ii) Mamata Das (F/36) w/o Lt. Mritunjoy Roy of Simultala, PO+PS Matigara, Dist. Darjeeling with the following articles under proper seizure as per seizure list;

a) One Green coloured Medium Bag containing 5 kgs 185 grams of said to be Ganja recovered and seized from the joint and conscious possession of Gouri Debnath and Mamata Das and marked as "Exhibit- A".

I, SI Abhishek Theengh (32), S/O- Suchandra Kumar Theengh of Pradhan Nagar Police Station, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted accused persons namely (i) Gouri Debnath (F/55) w/o Shyamal Debnath of Jamuri Vita, 1. No. Fulbari, PS NJP, Dist. Jalpaiguri (ii) Mamata Das (F/36) w/o Lt. Mritunjoy Roy of Simultala, PO+PS Matigara, Dist. Darjeeling to the effect that on 04.09.2023 at about 14.20 hrs, I received a specific source input that two lady persons possessing huge quantity of said to be Ganja was standing at Naya Busty 3 No. Lane, under Pradhan Nagar PS to sell the same to their designed local customers. The matter was diarized in Pradhan Nagar PS GDE No. 228/23 Dt. 04.09.2023. Subsequently, I informed the matter to you on written and with your prior permission and being directed, myself along with ASI Manoj Kumar Roy, ASI Amar Raj Subba, ASI Biplab Kumar Das, LC/338 Subha Rai, C/762 Mojhebur Rahaman, CV-223 Swapan Chettri, CV/128 Ajay Sahani all of Pradhan Nagar PS, SPC, and with investigation kit left for Naya Busty 3 No. Lane, under Pradhan Nagar PS PS by Govt. vehicle to verify the veracity of the information. This refers to Pradhan Nagar PS GDE No. 228/23 Dt. 04.09.2023 and M.C.C No- 2197 Date- 04.09.2023.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

After reaching at Naya Busty 3 No. Lane under Pradhan Nagar PS at around 15.15 hrs, I requested two persons as independent witness by notice namely (1) Janmara Khatoon (F/35) W/O Noor Akhtar of Nayabusty, Salbari, PS Pradhan Nagar, Dist. Darjeeling and (2) Nasimor Necha (F/52) W/O Lt. Musaru Hussain of Naya Busty, Salbari, PS Pradhan Nagar, Dist. Darjeeling and made them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed and thereafter being pointed by my source detained 02 (Two) lady persons mentioned above who was standing at Naya Busty 3 No. Lane, under Pradhan Nagar PS. They had carried Green coloured Medium Bag under their joint and conscious possession.

Thereafter, we disclosed our identity and the information in hand and stated them that they as well as the bag under their possession will be searched for the purpose. And, I gave them option in writing to be searched in presence of an Executive Magistrate or by any Gazetted Officer upon which they agreed to be searched in presence of any one of the above.

I also offered the independent witnesses and the accused lady persons to search our Police Party as per provisions but they did not search the police party. Consequently, I informed the matter to you and as per your kind order, I informed to Shri Manish Kumar Yadav, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC for the day, regarding the interception of the accused lady persons suspected to be possessed said to be Ganja illegally and requested him to come at Naya Busty 3 No. Lane under Pradhan Nagar PS to remain present and to supervise the search and seizure.

Accordingly at 16.30 hrs Shri Manish Kumar Yadav, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC arrived at the spot at Naya Busty 3 No. Lane under Pradhan Nagar PS as Special Executive Magistrate, SPC and in presence of two independent witnesses and hereafter both the lady accused persons was searched by LC/338 Subha Rai of Pradhan Nagar PS, following all formalities, keeping their decency and recovered the above noted articles from the joint and conscious possession of the accused lady persons namely Gouri Debnath and Mamata Das.

Further, on demand in presence of Shri Manish Kumar Yadav, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC, the detained persons namely Gouri Debnath and Mamata Das, on being asked, failed to produce any valid documents/papers or explanation for possessing of such a huge quantity of said to be Ganja.

Thereafter, I seized 5 kgs 185 grams from the joint and conscious possession of Gouri Debnath and Mamata Das which was kept inside one Green coloured Medium Bag at the spot at Naya Busty 3 No. Lane under Pradhan Nagar PS under proper seizure list in presence of independent witnesses and Shri Manish Kumar Yadav, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC obtaining their signature and being acknowledged by the accused lady persons.

Subsequently, I labelled and sealed the seized articles in presence of Shri Manish Kumar Yadav, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate, SPC and independent witnesses and the accused lady persons namely Gouri Debnath and Mamata Das. The whole process of seizure was made in between 17.35 hrs to 18.40 hrs.

Being further asked, the apprehended lady persons namely Gouri Debnath and Mamata Das admitted in presence of Shri Manish Kumar Yadav, Assistant Commissioner of Police, Siliguri Police Commissionerate detailed for acting as Special Executive Magistrate of SPC and other independent witnesses that they have procured illegal said to be Ganja clandestinely for the purpose of selling the same in high rate to their designed local customers for their personal gain by illegal means. On further being asked, they also disclosed that they have been dealing in this business of procuring and selling of said to be Ganja illegally for last few months for their wrongful gain.

From the above noted facts and seizure of incriminating articles it is quite evident that the accused lady persons namely Gouri Debnath and Mamata Das is involved in procuring and selling of said to be Ganja illegally contravening the norms of NDPS Act.

Then, I arrested the above noted accused lady persons namely Gouri Debnath and Mamata Das after observing all formalities and informing the ground of their arrest and issued necessary Memo of Arrests respectively duly signed by the arrested lady accused persons, witnesses and LC/338 Subha Rai and subsequently the family members of the arrested accused lady persons has been informed.

Under the above circumstances, I pray to you that a specific case under proper section of law may kindly be started against the accused lady persons namely (i) Gouri Debnath (F/55) w/o Shyamal Debnath of Jamuri Vita, T. No. Fulbari, PS NJP, Dist. Jalpaiguri (ii) Mamata Das (F/36) w/o Lt. Mritunjoy Roy of Simultala, PO+PS Matigara, Dist. Darjeeling and arrange for its investigation.
