With due regards, I, SMT. SUKANYA SAHA (CHOUDHURY), Wife of Sri Prasenjit Saha, Daughter of Late Biswanath Choudhury, Presently residing at Chandralaya Apartment, Children's Park, Near Ganga Sweets, P.O. & P.S. Siliguri, Dist. Darjeeling, would like to lodge this written complaint to the effect that SRI PRASENJIT SAHA, Son of Sri Ranjit Saha, Resident of 46/2, Raja Ram Mohan Roy Road, "Krishnalal Bhawan", Hakim Para, Ward No. 15 of S.M.C., Siliguri, P.O. & P.S. Siliguri, Dist. Darjeeling, Pin: 734001, is my legally married husband and our marriage was solemnized on 15.02.2006, according to the Hindu Rites and Customs, after observing all formalities of a Hindu Marriage on and from the Baba Loknath Mandir Mission, Dagapur, P.S. Pradhan Nagar, Dist. Darjeeling, and subsequently, our marriage was registered on 23.02.2012, as per the provision of Hindu Marriage Act, 1955, before the Additional District Sub-Registrar & Ex-Officio, Hindu Marriage Registrar, vide Registration St. No. 68/2012.

It is to be mentioned here that at the time of our marriage, my mother and other family members had given so many valuable articles like golden ornaments, furniture & fixtures, utensils, clothing's and other valuables which are required to start a new conjugal life, as per the demand of my husband and his family members and also considering my better future conjugal life and thereafter, my husband in conspiracy with his family members, have taken all the aforesaid articles in their custody SILIGUE WOMEN P.S. they are trying misappropriate the same for their turongful and illegal gain.

After our marriage, my husband brought me at his house as mentioned aforesaid, where we started to live and cohabited together as husband and wife and out of our lawful wedlock, one female child was born on 01.01.2015, whose name is Miss. Adrika Saha, who is bringing up under my care and custody and presently, she is studying in Class – II at Nirmala Convent School, Siliguri.

Madam, I have entered into my matrimonial house with lot of dreams and hopes with a view to lead a happy conjugal life with my husband and in laws members but very surprisingly, just after few days of our marriage, I found and noticed some radical changes in the attitude and behavior of my husband and his family members. Just after lapse of some times, I found and noticed the abnormal changes in the attitude and behavior of my husband and also noticed that my husband is a habitual

heavy manner and return back home at late nights and when I asked about his such type of activities, he picked up quarrel and started to inflict torture upon me both physically and mentally in presence of other family members and inspite of knowing the aforesaid torture of my husband, they did not make any protest and on contrary, they have encouraged my husband to continue such type of activities upon me.

I, being his legally married wife, always tried my level best to adjust with my husband and in laws members and also tried to understood my husband not to take those drugs and alcohol in such manner as the same are very dangerous to his health but he did not pay any heed to my request and continued his such type of activities as usual and increased the parameter of torture upon me day by day and I used to bear such type of illegal activities and torture of my husband and in laws members with a hope that in future they will definitely realize their own mistake and thereby, rectify themselves but all my hopes have gone in vain due to their continuous ill torture and behavior.

Thereafter, due to the continuous consumption of alcohol and drugs by my husband, the situation became worse and after few months of our marriage, my husband had suffered a severe stomach pain and I being a dutiful wife, have compelled to took my husband before the Doctor and considering his serious condition, as per the direction of the Doctor, I admitted him at Sunrise Nursing Home, Siliguri and made necessary treatments according to my best efforts in order to cure him from the said disease and pain and after thorough checkup and treatment, it was diagnosed that due to huge consumption of alcohol and drugs, he has been suffering with the disease of Pancreas and thereafter, finding no other alternative, my husband was taken to Hyderabad for his better treatment of Pancreas and after curing partially from the said disease, the Doctor discharged him with certain instructions.

After those incidents, I thought that now he may change his earlier acts & activities and rectify himself and lead a happy conjugal life with me but gone in vain. Thereafter, my husband told me that he wants to start his own business for which, huge amount of money is required and all the family members of my husband have asked and induced me to mortgage my property which I have acquired from my parents, before the Bank in order to obtain loan for his business purpose and also assured me that after some period, they will release my said property from the Bank after repaying all the loan amounts to the concerned Bank and on being induced by my husband and his family members, I have also agreed with their said proposal and obtained a loan from the Bank after mortgaging my property but it is very unfortunate and painful to mention here that after obtaining the huge amount of loan after mortgaging my own property, they have misappropriated all those money for maintaining their luxurious and lavish lifestyle by playing gambling and consuming alcohol and drugs and thereafter, in order to repay the said loan amount, I have sold out the said property and also my ornaments and repaid the said loan amount.

Thereafter, day by day, the situation became worse and it was not possible for me as well as for my parents to tolerate my husband and his family members and finally, my in laws admitted my husband in a Rehab

Center namely Genesis Foundation at Pradhan Nagar where he was admitted for a long period about 7 months i.e. on and from 11.02.2019 to 05.09.2019, in order to rectify his said activities and also to cure him from his said addiction but even after staying such long period in the Rehab Center, nothing was changed in the nature and character of my husband and after releasing from the said Rehab Center, he again started to pass his lavish lifestyle again by consuming huge quantity of alcohol and drugs and in every night, he used to return back home in fully drunken condition with no human sense and used to vomit in front of our minor daughter which was not acceptable for me and considering the said situation, when I made protest against his such type of regular activities, he became furious and started to assault me in front of our minor daughter and also threatened me to oust me from his house with my minor daughter and thereafter, finding no other alternative, in the month of May, 2021, I have compelled to leave my matrimonial house with my minor daughter in a single wearing apparels in order to save our life. It is very painful to mention here that when my husband was admitted at Rehab Center, my in laws members in conspiracy with each other have committed several torture upon me with an intention to oust me from my matrimonial house.

After leaving my matrimonial house, I have filed one Matrimonial Suit against my husband which is pending before the Court of Law and I have also filed an application for maintenance which is also pending before the Ld. Court and immediately after receiving notice/summon from the Ld. Court, my husband and in laws members became more violent and started to threaten me with dire consequences and created pressure upon me to withdraw those cases otherwise, they will not hesitate to ruin my life and property permanently and nobody will do anything against them as they have very good nexus with the anti-social persons of the locality and suddenly on 21.08.2023 at about 02.00 P.M., when I was waiting at the Bus Stop in order to receive my daughter, my husband appeared there and started to threaten me and when I opposed his such type of activities, he became furious and also slapped me and also threatened me if I lodge complaint against them, they will teach me a good lesson and due to such type of inhuman torture and threatening of my husband and in laws members, I along with my minor daughter have been passing our days with extreme fear and mental anxiety.

I, therefore, request you to kindly investigate into the matter and please take appropriate strong legal action against my husband and in laws members as mentioned aforesaid as per the provision of law and obliged thereby.
