- 5. That in a month of March 2023 my husband and my aforesaid in-laws dorve me and my minor daughter out from my in-laws house after mercilessly assaulting me.
- 6. That thereafter salishi meeting was held but my husband flatly denied to leave with me as husband and wife and asked me to give divorce to him.
- 7. That since after that I have been living in my mother's house at above mentioned address and my husband never came to see us nor he provided single penny for our maintenance.
- 8. That on 23.8.2023 I came to know my husband has married again with one lady namely Monika Sarkar, D/O.
