With due respect, I, SI Biswajit Sarkar of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this written complaint against accused namely; (1) Tapan Ghosh (63 yrs/M) S/o- Lt. Atal Ghosh of Unnayon Colony, North Bharat Nagar, W/no- 24, PS- Siliguri, Dist- Darjeeling after producing him under arrest along with following articles;

1) 15 (Fifteen) Sealed Bottles Himalayan Gold premium 60 Up Country Spirit each containing 600 Ml Rs. 155/- each total 9. 000 Ltrs. (Valued total Rs. 2325/-), under proper seizure

list, labeling and memo of arrest.

.In this regard I beg to report that on 05.09.23 at 18:25 hrs received secret source information that the above noted accused person was busy to sale Id Liquor illegally backside of TMC Party Office near Fuleswari Railgate under Siliguri PS. Accordingly I informed the fact to I/C Siliguri PS and as per his direction I along with ASI Subir Sen, ASI Debasish Das, CV/622 Ramanath Barman, CV/283 Prasenjit Dey left for Fuleswari Railgate under Siliguri PS vide Siliguri PS GDE no- 326 dated 05/09/23. On reaching Fuleswari Railgate at 18:35 hrs there and as identified by the source cordoned the above noted area where he was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we manage to apprehend the above noted accused person and on interrogation he disclosed his identity as he disclosed his name and idendity as Tapan Ghosh (63 yrs/M) S/o- Lt. Atul Ghosh of Unnayon Colony, North Bharat Nagar, W/no-24, PS- Siliguri, Dist- Darjeeling . On interrogation he admitted that he had been selling the above noted seized articles to the customers in concealed manner at his locality. In presence of witnesses, I demanded him to produce the documents or license, cash memo of the said liquor but he failed to produce any documents in support of above noted illicit liquor and selling the same to customers for his wrongful gain. I, accordingly seized those illicit liquors in between 19:15 hrs to 19.40 hrs in presence of independence witnesses namely (i) Raj Dutta (22 yrs) S/O - Kali Dutta of North Bharat Nagar near Tiger Sporting Club, W/No-24, P.S-Siliguri Dist, Darjeeling (ii) Subrata Singha (·18 yrs) S/O- Bipul Singha of North Bharat Nagar near Tiger Sporting Club, W/No-24, P.S-Siliguri Dist, Darjeeling after preparing proper seizure list duly signed by the witnesses and accused, also labeled the same. Then, I arrested him U/S 41 CrPC after informing his ground of arrest.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused namely Tapan Ghosh (63 yrs/M) S/o- Lt. Atul Ghosh of Unnayon Colony, North Bharat Nagar, W/no- 24, PS- Siliguri, Dist- Darjeeling along with seized articles under proper section of law and arrange for its investigation.
