Jalpaiguri, (2) Ashim Biswas (M/44), S/O-Lt. Aswhini Biswas of South Bharat Nagar, W/No - 24, PS. Siliguri, Dist. Darjeeling, and (3) Krishna Sahani (M/20), S/O- Lt. Arun Sahani of Koyla Depo, W/No - 07, PS. Siliguri, Dist. Darjeeling (4) Jayanta Mohanta @ Kathal (26 yrs) S/O- Lt. Ram Mohanta of Durga Das of Durga Das Colony, Ward No-20, PS- Siliguri, Dist- Darjeeling (5) Tapash Mohanta (23 yrs) S/O- Lt. Ram Mohanta following seized articles viz:

- I, ASI- Debasish Das S/O Haripada Das of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons and others viz. Sherua, Karan, Nandu, Kala Tapash , Manua,@ Motra and others to the effect that today on 06.09.2023 at 00.30 hrs received a sources information that 15/16 youths have assembled at North Bharat Nagar near Rail Line with a view to commit dacoity in a house at Bharat Nagar area. The fact was diarized in GD vide Siliguri PS GDE No-347, dated 06.09.2023. Subsequently after sharing the information with I/C Siliguri PS and as per his direction, myself along with ASI- Subir Sen, CV/622 Ramanath Barman and GV/283 Prasenjit Dey, left for the place to work out the information. On way I contact SI Ramanath Karjee who was performing k-22 Van to accompany us to work-out the information. We reached at North Bharat near Tarun Tirtha club at 01.05 hrs and subsequently cordoned off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and was about to move from North Bharat Nagar near Rail Line seeing police personnel they tried to flee away from the spot but on hot chase we managed to apprehend above noted Five (05) accused persons along with seized articles as mentioned above. However the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at North Bharat Nagar area with the leadership of Ashim Biswas.

I thereafter, seized the above noted weapons under proper seizure list duly signed by the witnesses and acknowledged by the accused persons. The whole seizure was made in between 01.45 hrs to 02.20 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons and also supplied the copy of the memo of arrest to them.

Accordingly brought the arrested accused persons along with seized article at Siliguri Police Station for further investigation. During the course of interrogation it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house at North Bharat Nagar area. It is also revealed from them that (1) Sherua, (2) Karan, (3) Nandu (4) Kala Tapash (5), Manua, (6) Motra and some others have been assembled there with them and planned for committing the dacoity...

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz.
