Harman Ali R/o Digra bita P.O Tarbandha P.S Bagdogra along with 20 other unknown persons along with wooden sticks and covered faces stopped us and started searching our belongings and when I told them not to do the same they became so furious and started Assaulting me with fist and blows and with Bamboo Sticks as a result of which I sustained Multiple injuries over my body and for which I have also taken Medical Attention in Bagdogra Primary health checkup center so finding no way out and worried for my life I am lodging this complaint in your P.S with a view that proper necessary Actions taken Against them
