In producing herewith Five (05) arrested accused persons namely (i) Kiran Chettri (32) s/o Hem Bahadur Chettri of Durgaguri, PS Pradhan Nagar, Dist. Darjeeling (ii) Pritam Gurung (27) s/o Lt. Gopal Gurung of Pratap Gaon, PS Mirik, Dist. Darjeeling (iii) Sunil Tamang @ Jabra (28) s/o Shankar Tamang of Devi Danga, PS Pradhan Nagar, Dist. Darjeeling (iv) Rahul Roy (25) s/o Lt. Mahindra Roy of BRI Colony, Ward No. 01, PS Pradhan Nagar, Dist. Darjeeling (v) Ratnadeep Sen Roy @ Deep (31) s/o Manoj Sen Roy of Ramkrishna Colony, Ward No. 47, PS Pradhan Nagar, Dist. Darjeeling arrested u/s-41 Cr.P.C along with following seized articles viz:

(1) One iron made Knife measuring 4.7 inch (approx.) recovered and seized from the possession of Kiran Chettri which was kept concealed on his left jeans pocket.

(2) One iron made sickle measuring 9.4 inch (approx.) including butt from the possession of Pritam Gurung which was kept concealed on his back side.

(3) One iron made sickle measuring 9.4 inch (approx.) including butt recovered and seized from the possession of Sunil Tamang @ Jabra which was kept concealed on his back side.

(4) One long iron rod measuring 22 inches recovered and seized from the possession of Rahul Roy.

(5) One iron made sickle measuring 9.4 inch (approx.) including butt recovered and seized from the possession of Ratnadeep Sen Roy @ Deep which was kept concealed on his back side

(6) Two long iron measuring 26 inch (approx.) and 30 inches (approx.) in length found from the place of occurrence.

(7) Two torch light found from the place of occurrence.

I, SI Abhishek Theengh, S/O- Suchandra Kumar Theengh of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted accused persons namely i) Kiran Chettri ii) Pritam Gurung iii) Sunil Tamang @ Jabra (iv) Rahul Roy (v) Ratnadeep Sen Roy @ Deep and others to the effect that today on 06.09.2023 at 00.05 hrs. received a sources information that 14/15 youths have assembled below Mahananda Bridge near Gurung Busty under Pradhan Nagar PS with a view to commit dacoity in a house at Gurung Busty area. The fact was diarized in GD vide Pradhan Nagar PS GDE No-313, dated 06.09.2023. Subsequently, after sharing the information with my superiors and as per their direction, I along with C/762 Mojhebur Rahaman, CV/128 Ajay Sahani, CV/223 Swapan Chettri, CV/645 Pankaj Gupta left for the place to work out the information. At about 00.12 hrs. after reaching below Mahananda Bridge near Gurung busty under PS-Pradhan Nagar, I met my source and being pointed by the source we started walking towards the spot and started cordoning off the suspected persons as shown by the source with a strong reason to believe that they were preparing to commit some cognizable offence and were about to move from the spot and seeing police personnel approaching towards them, they tried to flee away but on a hot chase we managed to apprehend above noted Five (05) accused persons along with seized articles as mentioned above. However, the other persons managed to flee away from the spot taking the advantage of darkness. On interrogation the accused persons admitted that they had assembled there to commit dacoity in a house at Gurung busty area.

I thereafter, seized the above noted weapons under proper seizure list and acknowledged by the accused persons. The whole seizure was made in between 00.25 hrs to 00.58 hrs. Thereafter, I arrested the above noted accused persons u/s 41 Cr.P.C under proper memo of arrests duly signed by the accused persons after informing the ground of arrest.

I accordingly brought the arrested accused persons along with seized article at Pradhan Nagar Police Station for further investigation. During the course of interrogation, it could be revealed from the arrested accused persons that they were gathered there to commit dacoity in a house of Gurung busty area.

Hence, a specific case may kindly be started under proper section of Law against the above noted accused persons viz. (i) Kiran Chettri (32) s/o Hem Bahadur Chettri of Durgaguri, PS Pradhan Nagar, Dist. Darjeeling (ii) Pritam Gurung (27) s/o Lt. Gopal Gurung of Pratap Gaon, PS Mirik, Dist. Darjeeling (iii) Sunil Tamang @ Jabra (28) s/o Shankar Tamang of Devi Danga, PS Pradhan Nagar, Dist. Darjeeling (iv) Rahul Roy (25) s/o Lt. Mahindra Roy of BRI Colony, Ward No. 01, PS Pradhan Nagar, Dist. Darjeeling (v) Ratnadeep Sen Roy @ Deep (31) s/o Manoj Sen Roy of Ramkrishna Colony, Ward No. 47, PS Pradhan Nagar, Dist. Darjeeling and others and arrange for its investigation.
