In producing herewith one accused person namely Pradeep Sharma-40yrs s/o Lt Ghana Shyam Sharma of Toribari Ghat, P.O- Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri along with the following seized articles as per proper seizure list:

1. 24 (Twenty four) no's of Tuborg Strong Beer each bottle containing 650 ML which was packed in one big nylon hand bag.

With due respect and humble submission, I SI Rantu haldar of Bhaktinagar PS under Siliguri Police Commissionerate do hereby lodge this written complaint after producing herewith the above noted seized articles to the effect that on 05.09.2023 at 14.10hrs while performing PS mobile van duty received a source information from Toribari Ghat under Bhaktinagar PS that one person namely Pradeep Sharma was selling wine in the open market for his wrongful gain without any documents/license in his house. Diarized the fact in GD vide Bhaktinagar PS GDE No- 229 dated 05.09.23. As per your kind instruction myself along with PSI Chiranjit Saha, C/374 Debraj Biswas, CV/935 Biplab Roy proceeded to the PO to work out the information. At 16.40 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his house. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from the PO after prepared proper seizure list. (The seizure was made in between 17.05hrs to 17.35 hrs)

I therefore request you a specific case may kindly be started against the accused person namely Pradeep Sharma-40yrs s/o Lt Ghana Shyam Sharma of Toribari Ghat, P.O- Salugara, P.S- Bhaktinagar, Dist- Jalpaiguri under proper section of law and arrange for investigation.
